5 A RESOLUTION CONFIRMING THE APPOINTMENT OF
6 DAVIDA M. CARTER, A CLAY COUNTY RESIDENT, AS A
7 MEMBER OF THE KINGSOUTEL CROSSING COMMUNITY
8 REDEVELOPMENT AGENCY ADVISORY BOARD, AS A
9 REPRESENTATIVE FROM THE BANKING PROFESSION, IN
10 ACCORDANCE WITH SECTION 53.202, *ORDINANCE CODE*,
11 REPLACING KEMAL GASPER, FOR A FIRST FULL TERM
12 EXPIRING DECEMBER 31, 2027; ESTABLISHING THAT
13 THE APPOINTEE, A NON-RESIDENT OF DUVAL COUNTY,
14 HAS A SUBSTANTIAL BUSINESS INTEREST IN DUVAL
15 COUNTY, IN ACCORDANCE WITH SECTION 50.102
16 (MEMBERS OF BOARDS AND COMMISSIONS), PART 1
17 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF
18 BOARDS AND COMMISSIONS), *ORDINANCE CODE*;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT RESOLVED** by the Council of the City of Jacksonville:

22 **Section 1. Appointment.** The Council hereby confirms the
23 appointment of Davida M. Carter, a Clay County resident, as a member
24 of the KingSoutel Crossing Community Redevelopment Agency Advisory
25 Board, as a representative from the banking profession, in accordance
26 with Section 53.202, *Ordinance Code*, replacing Kemal Gasper, for a
27 first full term expiring December 31, 2027.

28 **Section 2. Establishing that the Appointee has a**
29 **Substantial Business Interest in Duval County.** Section 50.102(b)
30 (Members of boards and commissions), Part 1 (Organization), Chapter
31 50 (Organization of Boards and Commissions), *Ordinance Code*, requires

1 Board and Commission members are either permanent residents of Duval
2 County or they maintain a substantial economic business interest or
3 substantial philanthropic interest, as determined by the City
4 Council, within Duval County. Although the appointee does not reside
5 in Duval County, Ms. Carter has worked for 24 years at VyStar Credit
6 Union located at 76 S. Laura Street, Jacksonville, Florida 32202,
7 where she currently serves as the Senior Vice President of
8 Investments. Therefore, the Council has determined that Ms. Carter
9 maintains a substantial business interest in Duval County.

10 **Section 3. Effective Date.** This Resolution shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
