

**NCSPHS AMENDMENT #12**

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following twelfth amendment to File No. 2023-807:

- (1) On **page 3, lines 15-23** strike "APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO NEGOTIATE, EXECUTE, AND DELIVER AN AGREEMENT BETWEEN THE CITY AND OPPORTUNITY DEVELOPMENT, INC., A FLORIDA NON-PROFIT CORPORATION, DOING BUSINESS AS CENTER FOR INDEPENDENT LIVING JACKSONVILLE ("CIL JACKSONVILLE"), TO ASSIST PERSONS WITH DISABILITIES;"
- (2) On **page 4, lines 13-18**, strike "INVOKING THE EXCEPTION OF SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH CIL JACKSONVILLE TO ASSIST PERSONS WITH DISABILITIES;"
- (3) On **page 5, lines 11-17**, strike "WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW A DIRECT CONTRACT WITH CIL JACKSONVILLE TO ASSIST PERSONS WITH DISABILITIES;"
- (4) On **page 7, line 16**, strike "Revised On File" and insert "Eleventh Revised On File";
- (5) On **page 14, lines 15-31 and page 15, lines 1-13**, strike Section 9 in its entirety;
- (6) Renumber the remaining Sections accordingly;
- (7) On **page 16, lines 24-31 and page 17, lines 1-2**, strike Section 14 in its entirety;

- (8) Renumber the remaining Sections accordingly;
- (9) On **page 18, lines 21-31, strike** Section 19 in its entirety;
- (10) Renumber the remaining Sections accordingly;
- (11) Remove **Revised On File** and replace with **Eleventh Revised On File**, attached hereto, which attaches the eleventh revised Mayor's Task Force Programs and Initiatives Summary to reflect that services related to the Disabled Community Support program will be procured through a Request for Proposal process and to delete the reference to Exhibit 7;
- (12) Remove **Exhibit 7**;
- (13) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
