6 AN ORDINANCE APPROPRIATING \$750,000 FROM THE  
7 SOUTHSIDE TENNIS COMPLEX - OTHER CONSTRUCTION  
8 COSTS ACCOUNT TO THE MULTIYEAR PROGRAMS AND  
9 INITIATIVES FUND - COUNCIL DISTRICT 05 -  
10 CONTINGENCY ACCOUNT TO RETURN A PORTION OF THE  
11 FUNDING ORIGINALLY APPROPRIATED FROM THE COUNCIL  
12 DISTRICT 5 COMMUNITY BENEFITS AGREEMENT  
13 CONTINGENCY ACCOUNT AS PART OF THE FISCAL YEAR  
14 2025-2026 BUDGET APPROVED BY ORDINANCE 2025-504-  
15 E; AMENDING THE 2026-2030 FIVE-YEAR CAPITAL  
16 IMPROVEMENT PROGRAM APPROVED BY ORDINANCE  
17 2025-505-E TO REFLECT THIS APPROPRIATION OF  
18 FUNDS FROM THE PROJECT ENTITLED "SOUTHSIDE  
19 TENNIS COMPLEX"; PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2025-2026 fiscal year,  
23 within the City's budget, there are hereby appropriated the indicated  
24 sum(s) from the account(s) listed in subsection (a) to the account(s)  
25 listed in subsection (b):

2 (c) Explanation of Appropriation

3 The funding above represents an appropriation of \$750,000  
4 from the Southside Tennis Complex - Other Construction  
5 Costs account to the Multiyear Programs and Initiatives  
6 Fund - Council District 05 Contingency account to return a  
7 portion of the funding originally transferred from the  
8 Council District 5 Community Benefits Agreement  
9 Contingency account as part of the Fiscal Year 2025-2026  
10 budget approved by Ordinance 2025-504-E.

11 **Section 2. Purpose.** The purpose of the appropriation in  
12 Section 1 is to return a portion of the funds appropriated by  
13 Ordinance 2025-504-E from the Council District 5 Community Benefits  
14 Agreement Contingency account to the Capital Improvement Plan project  
15 entitled "Southside Tennis Complex" (the "Project"). The District 5  
16 Council Member has identified another purpose for which he intends  
17 to use these District 5 Community Benefits Agreement funds.

18 **Section 3. Capital Improvement Plan Amendment.** Ordinance  
19 2025-505-E, adopting the 2026-2030 Five-Year Capital Improvement Plan  
20 (the "CIP") for the City and certain of its independent agencies, is  
21 hereby amended to reflect this appropriation of funds from the  
22 Project, as reflected in the Project Information Sheet attached hereto  
23 as **Revised Exhibit 2**, labeled as "Revised Exhibit 2, Rev CIP Sheet,  
24 March 3, 2026 - Finance" and incorporated herein by this reference.  
25 The City Council finds that the deferral of this amendment of the CIP  
26 until the next annual budget and CIP review will be detrimental to  
27 the best interests of the community because the Project will not be  
28 completed for some time and the District 5 Council Member has  
29 identified other priority needs for the community that can be more  
30 readily addressed through this reallocation of Council District 5  
31 Community Benefits Agreement funds.

1 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of  
2 this Ordinance requires the affirmative vote of two-thirds of the  
3 City Council members present at the meeting because of the CIP  
4 amendment set forth in this section. This Ordinance shall constitute  
5 an amendment to Ordinance 2025-505-E. In all other respects, the  
6 Five-Year Capital Improvement Plan approved by Ordinance 2025-505-E  
7 shall remain unchanged and continue in full force and effect.

8 **Section 4. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
