5 AN ORDINANCE APPROPRIATING \$1,341,426.94 FROM
6 THE COUNCIL PRESIDENT’S DESIGNATED CONTINGENCY
7 TO ACTIVITIES FOR EACH OF THE 14 COUNCIL
8 DISTRICTS TO FUND OPERATING AND/OR CAPITAL PARKS
9 OR PUBLIC WORKS PROJECTS AND IMPROVEMENTS IN
10 EACH COUNCIL DISTRICT AS DETERMINED APPROPRIATE
11 BY EACH DISTRICT COUNCIL MEMBER AND IN
12 ACCORDANCE WITH THE APPLICABLE PROVISIONS OF
13 SECTION 106.315 (DISTRICT COUNCIL
14 EXPENDITURES), *ORDINANCE CODE*; PROVIDING FOR
15 CARRYOVER TO FISCAL YEAR 2024-2025; REQUESTING
16 ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
21 within the City’s budget, there is hereby appropriated the indicated
22 sum(s) from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

- 30 (c) Explanation of Appropriation:
31 The funding above is an appropriation of \$1,341,426.94 from

1 the Council President's Designated Contingency to be
2 divided equally amongst each Council District (\$95,816.21
3 per District) to fund operating and/or capital projects
4 and improvements in each District related to parks and/or
5 public works as determined appropriate by each District
6 Council Member and in accordance with Section 106.315,
7 *Ordinance Code*.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 is to allocate \$95,816.21 to each of the 14 Council
10 Districts to fund various operating and/or capital parks or public
11 works related projects and improvements as determined by the District
12 Council Member. Expenditures made pursuant to this appropriation
13 shall comply with the applicable provisions of Section 106.315
14 (District Council expenditures), *Ordinance Code*. In the event a
15 District Council Member desires to expend all or any portion of the
16 funds appropriated hereby for a purpose or project not authorized
17 herein, such an appropriation shall require introduction of
18 legislation for approval by the City Council. It is the express intent
19 that any alternative uses of these funds requested through subsequent
20 legislation would be appropriated in amounts not less than \$25,000.

21 **Section 3. Carryover.** The funds appropriated herein shall
22 not lapse but shall carryover to fiscal year 2024-2025.

23 **Section 4. Requesting One Cycle Emergency Passage Pursuant**
24 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
25 legislation is requested. The nature of the emergency is to allow
26 these funds to be appropriated and made available to each District
27 Council Member by the end of this Council year (June 30th).

28 **Section 5. Effective Date.** This Ordinance shall become
29 effective upon signature by the Mayor or upon becoming effective
30 without the Mayor's signature.
