AN ORDINANCE RENAMING THE PUBLIC PARK CURRENTLY KNOWN AS "OAKLAND PARK," LOCATED AT 657 EAST UNION STREET, JACKSONVILLE, FLORIDA 32206, IN COUNCIL DISTRICT 7, PURSUANT TO SECTION 122.105 (PUBLIC BUILDINGS, PUBLIC FACILITIES AND PUBLIC PARKS NAMING AND RENAMING PROCEDURES), ORDINANCE CODE, TO BE KNOWN AS "EARTHA M. M. WHITE HISTORICAL PARK"; PROVIDING AN EFFECTIVE DATE.
