

NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File No. 2024-452:

- (6) On **page 4, lines 2, 5 and 7, strike** "B.T. 24-113" and **insert** "Revised B.T. 24-113";
- (7) On **page 4, line 2, strike** "Exhibit 2" and **insert** "Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev B.T. 24-113, June 17, 2024 - NCSPHS"";
- (8) On **page 4, lines 9-10, strike** "Debt Management Fund, Long Term Debt Issued" and **insert** "General Fund Operating Reserves";
- (9) On **page 4, line 14, strike** "project" and **insert** "Project";
- (10) On **page 4, line 16, after "fund the" insert** "Construction";
- (11) On **page 4, lines 19-31 and page 5, lines 1-4, strike** Sections

3 and 4 in their entirety;

(12) Renumber the remaining Sections accordingly;

(13) On **page 6, line 6, strike** "of the";

(14) Remove **Exhibit 2** and replace with **Revised Exhibit 2**, attached hereto, which attaches the revised B.T. 24-113 to reflect the revised funding source;

(15) Remove **Exhibit 3**;

(16) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
