8 AN ORDINANCE APPROVING THE HARBOUR WATERWAY
9 DEPENDENT SPECIAL DISTRICT PROPOSED FISCAL
10 YEAR 2021/2022 BUDGET, PER ORDINANCE 2010-725-
11 E AND SECTION 189.02, *FLORIDA STATUTES*;
12 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, the City of Jacksonville established the Harbour
15 Waterway Dependent Special District (the "District"), per Ordinance
16 2010-725-E and section 189.02, *Florida Statutes*, a dependent
17 special district for the purpose of dredging the Harbour Waterway
18 canal system; and

19 **WHEREAS**, in order for the District to qualify as a dependent
20 special district per section 189.02, *Florida Statutes*, the City, in
21 Ordinance 2010-725-E, required the District to submit its proposed
22 budget to the City Council every year by April 1st; and

23 **WHEREAS**, the District has submitted the proposed Fiscal Year
24 2021/2022 budget to the City Council and is seeking approval of the
25 budget by the City Council; and

26 **WHEREAS**, the City Council finds that the Harbour Waterway
27 Dependent Special District proposed Fiscal Year 2021/2022 budget,
28 attached hereto as **Revised Exhibit 1**, labeled as "Revised Exhibit
29 1, Revised Budget, May 3, 2021 - NCSPHS", should be approved; now
30 therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Approval of Harbour Waterway Dependent Special**
3 **District Proposed Fiscal Year 2021/2022 Budget.** The Harbour
4 Waterway Dependent Special District proposed Fiscal Year 2021/2022
5 budget, attached hereto as **Revised Exhibit 1**, labeled as "Revised
6 Exhibit 1, Revised Budget, May 3, 2021 - NCSPHS", is hereby
7 approved.

8 **Section 2. Effective Date.** This ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
