- (5) On **page 3, line 7, <u>strike</u>** "2016-382-E" and <u>insert</u> "2024-286-
- (6) On page 4, lines 9-10, strike "amended and restated riverwalk improvements costs disbursement agreement" and insert "Amended and Restated Riverwalk Improvements Costs Disbursement Agreement";
- (7) On page 4, line 21, <u>strike</u> "and (8)" and <u>insert</u> "(8) authorize a revised Marina Management Agreement to revise the term and slip rental provisions, and (9)";

"Section 3. Designation of Authorized Official and Downtown Investment Authority as Contract Monitor. The Mayor is designated as the authorized official of the City for the purpose of executing and delivering any contracts and documents and furnishing such information, data and documents for the Agreements and related documents as may be required and otherwise to act as the authorized official of the City in connection with the Agreements, and is further authorized to designate one or more other officials of the City to exercise any of the foregoing authorizations and to furnish or cause to be furnished such information and take or cause to be taken such action as may be necessary to enable the City to implement the Agreements according to their terms. The Investment Authority is hereby required to administer and Hotel Redevelopment Agreement and monitor the related agreements referenced therein and to handle the responsibilities thereunder, including the responsibilities under such agreements working with and supported by all relevant City departments.

- Section 4. Oversight Department. The Department of Public Works and the Parks, Recreation and Community Services Department shall oversee the project described herein.";
- (11) Remove **On File** and replace with **Revised On File**, attached hereto, which attaches the revised Hotel Redevelopment Agreement and related agreements to reflect all changes approved by the Neighborhoods, Community Services, Public Health and Safety Committee;

(12) On **page 1, line 1,** amend the introductory sentence to add that the bill was amended as reflected herein.
