11 BUSINESS), CHAPTER 4 (PROCEDURES), *COUNCIL*
12 *RULES*, TO REARRANGE THE ORDER OF BUSINESS TO

14 CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Amending Council Rules 3.603 (Comments from the**
19 **Public), Chapter 3 (Legislation), Council Rules.**

20 Rule 3.603 (Comments from the Public), Chapter 3 (Legislation),
21 *Council Rules*, is hereby amended to read as follows:

26 **RULE 3.603 COMMENTS FROM THE PUBLIC**

27 The public comment portion of a regular Council meeting shall
28 be scheduled prior to the public hearings portion of each meeting
29 immediately following Actions upon resolutions on first or second
30 reading regarding economic development investment incentives and
31 related contracts, agreements and appropriations. ~~The public comment~~

1 ~~portion of a regular Council meeting shall be scheduled at the~~
2 ~~beginning of the business portion of each meeting immediately~~
3 ~~following Quasi-Judicial actions.~~ Comments from the public given
4 during the public comments portion of the meeting, except scheduled
5 public hearing comments, shall be limited to three minutes per person
6 and no person shall be allowed to give or transfer his/her time to
7 speak to another person. The Council shall reserve up to one and one-
8 half (1.5) hours of time for the public comment period. The deadline
9 for filling out and submitting a speaker's card for public comment
10 is 60 minutes after the published start time of the Council meeting.
11 When there are multiple speakers, the time allocated per person shall
12 be divided so as to allow as many speakers as possible a turn to
13 speak. Each person addressing the Council shall proceed to the place
14 assigned for speaking, give his/her name and county residence in an
15 audible tone of voice for the records.

30 times of the meeting, except scheduled public hearing comments, shall
31 be limited to no more than three minutes per person, and in accordance

3 ~~spoken at the first period of public comment shall be allowed to~~
4 ~~speak at the second period of public comment.~~

6 **Section 3. Requesting emergency one cycle passage pursuant to**
7 **Council Rule 4.901 Emergency.** One cycle emergency passage of this
8 legislation is requested. The nature of the emergency is that the
9 Council wishes to enact the modifications herein to the Council Rules
10 to be applicable with the new Council year beginning July 1, 2022.
11 Due to the Council break, without emergency action, implementation
12 of the changes would not occur until after the first meeting in August
13 2022.

14 **Section 4. Effective Date.** This Ordinance shall become
15 effective upon signature by the Mayor or upon becoming effective
16 without the Mayor's signature.
