THENCE CONTINUE NORTH 30°54'01" WEST ALONG SAID RIGHT OF WAY LINE, A DISTANCE OF 599.88 FEET TO THE SOUTHWESTERLY CORNER OF THOSE LANDS DESCRIBED IN OFFICIAL RECORDS VOLUME 8033, PAGE 1607 OF SAID PUBLIC RECORDS; THENCE NORTH 59° 05' 59" EAST, ALONG THE SOUTHEAST LINE OF THOSE LAST SAID LANDS, A DISTANCE OF 254.80 FEET TO THE SOUTHEAST CORNER OF SAID LANDS, SAID POINT ALSO LYING ON THE EASTERLY LINE OF THOSE LANDS DESCRIBED IN OFFICIAL RECORDS VOLUME 6793, PAGE 780; THENCE SOUTH 38° 35' 05" EAST, ALONG THE EASTERLY LINE OF LAST SAID LANDS, A DISTANCE OF 61.28 FEET TO THE MOST NORTHERLY CORNER OF THE LANDS DESCRIBED IN OFFICIAL RECORDS BOOK 12629, PAGE 186 OF SAID PUBLIC RECORDS; THENCE SOUTH 24° 51'31" EAST ALONG THE WEST LINE OF LAST SAID LANDS A DISTANCE OF 150.03 FEET TO THE SOUTH WEST CORNER OF SAID LANDS; THENCE NORTH 66°16'42" EAST ALONG THE SOUTHERLY LINE OF SAID LANDS A DISTANCE OF 215.00 FEET TO THE AFORESAID EASTERLY RIGHT OF WAY LINE OF PHILLIPS HIGHWAY AND A POINT ON A CURVE CONCAVE TO THE NORTHEAST AND HAVING A RADIUS OF 5,779,65 FEET; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE AND SAID RIGHT OF WAY LINE, A DISTANCE OF 177.02 FEET, MAKING A CENTRAL ANGLE OF 1°45'17", HAVING A CHORD BEARING OF SOUTH 24°41'13" EAST AND A CHORD DISTANCE OF 177.01 FEET; THENCE SOUTH 64°20'53" WEST RADIALLY TO LAST SAID CURVE AND CONTINUING ALONG SAID RIGHT OF WAY LINE A DISTANCE OF 12.50 FEET TO A POINT ON A CURVE CONCAVE TO THE NORTHEAST AND HAVING A RADIUS OF 5,792.15 FEET; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE 210.66 FEET, MAKING A CENTRAL ANGLE OF 02°05'02", HAVING A CHORD BEARING OF SOUTH 26°41'39" EAST AND A CHORD DISTANCE OF 210.64 FEET; THENCE SOUTH 67°14'22" WEST LEAVING SAID RIGHT OF WAY, A DISTANCE OF 127.61 FEET; THENCE SOUTH 59°51'08" WEST A DISTANCE OF 287.43 FEET TO THE POINT OF BEGINNING.
