6 AMOUNT OF \$148,000.00 FROM THE FLORIDA

8 22-23 CRIMINAL JUSTICE DATA TRANSPARENCY (CJDT)
9 IMPLEMENTATION ASSISTANCE PROGRAM, TO THE
10 JACKSONVILLE SHERIFF'S OFFICE TO IMPLEMENT THE
11 CRIMINAL JUSTICE DATA TRANSPARENCY/UNIFORM
12 ARREST AFFIDAVIT PROJECT, AS INITIATED BY B.T.
13 23-049; PROVIDING FOR OVERSIGHT BY THE
14 JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN
15 EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
19 within the City's budget, there are hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

28 (c) Explanation of Appropriation:
29 The funding above represents an appropriation of grant
30 funds from the Florida Department of Law Enforcement,
31 through its FY 22-23 Criminal Justice Data Transparency

1 (CJDT) Implementation Assistance Program, to the
2 Jacksonville Sheriff's Office to implement the Criminal
3 Justice Data Transparency/Uniform Arrest Affidavit project
4 (the "CJDT/UAA Project"). The grant period commenced on
5 July 1, 2022 and continues through June 30, 2023. No local
6 match is required.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to utilize grant funding from the Florida Department of
9 Law Enforcement to implement the CJDT/UAA Project. A portion of the
10 funds (\$65,000.00) will be used to purchase computer equipment
11 necessary to meet the technological requirements of the CJDT/UAA
12 Project, including storage, memory and CPU needs. The remaining
13 funds (\$83,000.00) will be used to procure professional services
14 required to meet Criminal Justice Data Transparency reporting
15 requirements, including development of an interface between the Jail
16 Management System and inmate look-up website, deploying a public
17 facing website, and completing custom file source coding needed to
18 meet Florida CJDT/UAA standards. A copy of the Grant Award outlining
19 the terms and conditions relative to the grant and use of the grant
20 funds is attached hereto as **Exhibit 2** and incorporated herein by this
21 reference.

22 **Section 3. Oversight.** The Jacksonville Sheriff's Office
23 shall oversee administration of the grant and project described
24 herein.

25 **Section 4. Effective Date.** This Ordinance shall become
26 effective upon signature by the Mayor or upon becoming effective
27 without the Mayor's signature.
