A PORTION OF THE NORTHWEST  $\frac{1}{4}$  OF THE SOUTHWEST  $\frac{1}{4}$  AND A PORTION OF GOVERNMENT LOT 4, SECTION 2, TOWNSHIP 1 SOUTH, RANGE 25 EAST, DUVAL COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT WHERE THE WESTERLY LINE OF SECTION 2 INTERSECTS THE NORTH LINE OF PLUMMER ROAD; THENCE EASTERLY ALONG SAID NORTH LINE OF PLUMMER ROAD, A DISTANCE OF 551.63 FEET; THENCE NORTH 1 DEGREE 50 MINUTES 10 SECONDS EAST, A DISTANCE OF 147 FEET; THENCE NORTH 9 DEGREES 02 MINUTES 20 SECONDS WEST, A DISTANCE OF 388.60; THENCE NORTH 56 DEGREES, 16 MINUTES, 50 SECONDS WEST, A DISTANCE OF 542.4 FEET; THENCE SOUTH 0 DEGREES 6 MINUTES WEST, A DISTANCE OF 617.2 FEET, TO A POINT OF BEGINNING.

PART OF THE NORTHWEST  $\frac{1}{4}$  OF THE SOUTHWEST  $\frac{1}{4}$  AND PART OF GOVERNMENT LOT 4, SECTION 2, TOWNSHIP 1 SOUTH RANGE 25 EAST, DUVAL COUNTY, FLORIDA AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AS THE NORTHEAST CORNER OF SAID NORTHWEST  $\frac{1}{4}$  OF THE SOUTHWEST  $\frac{1}{4}$ , THENCE SOUTH 89 DEGREES 57 MINUTES 05 SECONDS WEST ON THE NORTH LINE OF SAID NORTHWEST  $\frac{1}{4}$  OF THE SOUTHWEST  $\frac{1}{4}$ , 250 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE SOUTH 89 DEGREES 57 MINUTES 05 SECONDS WEST ON SAID NORTH LINE, 668.78 FEET; THENCE SOUTH 09 DEGREES 34 MINUTES 25 SECONDS EAST, 1341.64 FEET; THENCE SOUTH 00 DEGREES 06 MINUTES 40 SECONDS WEST, 540.37 FEET TO THE NORTH RIGHT-OF-WAY LINE OF PLUMMER ROAD (A 66 FOOT RIGHT-OF-WAY AS NOW ESTABLISHED); THENCE SOUTH 67 DEGREES 07 MINUTES 50 SECONDS EAST ON SAID NORTH RIGHT OF WAY LINE 126.58 FEET; THENCE NORTH 00 DEGREES 06 MINUTES 40 SECONDS EAST, 590.17 FEET; THENCE NORTH 13 DEGREES 57 MINUTES 45 SECONDS EAST, 1363.19 FEET TO THE POINT OF BEGINNING.

SOUTH 89 DEGREES 57 MINUTES 05 SECONDS WEST ON SAID NORTH LINE 400.60 FEET TO
