17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
19 within the City's budget, there is hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to provide funds for capital projects and improvements
5 for parks in Council District 5 to be used at the discretion of the
6 District Council Member.

7 **Section 3. Compliance with Section 106.315, Ordinance Code,**
8 **for District Council Expenditures Required.** Expenditures made
9 pursuant to this appropriation shall comply with the applicable
10 provisions of Section 106.315 (District Council Expenditures),
11 *Ordinance Code*. Funds appropriated in this Ordinance must be committed
12 before June 30, 2027. Failure to commit the funds before that date
13 shall cause said funds to revert to the account of origin.

14 **Section 4. Oversight.** The Parks, Recreation and Community
15 Services Department shall oversee the project described herein.

16 **Section 5. Effective Date.** This Ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
