5 **ORDINANCE 2022-835**

6 AN ORDINANCE APPROPRIATING \$4,000,000 FROM THE  
7 TOURIST DEVELOPMENT COUNCIL FUND BALANCE TO BE  
8 USED AS FOLLOWS: (1) \$2,000,000 TO THE TOURIST  
9 DEVELOPMENT COUNCIL CONTINGENCY PLAN COMPONENT,  
10 AND (2) \$2,000,000 TO THE TOURIST DEVELOPMENT  
11 COUNCIL OPERATIONS ACCOUNT; PROVIDING FOR AN  
12 EFFECTIVE DATE.

14 **WHEREAS,** at its October 20, 2022 meeting, the Tourist  
15 Development Council approved the appropriation of \$4,000,000 from the  
16 Tourist Development Council Fund Balance to increase the budget for  
17 the Contingency Plan component by \$2,000,000 and the Remaining to  
18 Spend category in the TDC operations activity by \$2,000,000; now  
19 therefore

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
22 within the City's budget, there is hereby appropriated the indicated  
23 sum from the account(s) listed in subsection (a) to the account(s)  
24 listed in subsection (b):

1 This ordinance appropriates \$4,000,000 from the Tourist  
2 Development Council Fund Balance to increase the budget  
3 for the Contingency Plan component by \$2,000,000 and the  
4 Remaining to Spend category in the TDC Operations activity  
5 by \$2,000,000.

6 **Section 2. Purpose.** The purpose of the appropriation in  
7 Section 1 is to appropriate \$4,000,000 from the Tourist Development  
8 Council Fund Balance to the TDC Contingency Account (\$2,000,000) to  
9 be added to the Contingency Plan component for unforeseeable  
10 opportunities and the TDC Remaining to Spend category in the  
11 Operations Account (\$2,000,000) to make funds available for use in  
12 the current fiscal year.

13 **Section 3. Effective Date.** This Ordinance shall become  
14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
