5 **ORDINANCE 2023-506-E**

6 AN ORDINANCE AUTHORIZING THE MAYOR, OR HER
7 DESIGNEE, AND THE CORPORATION SECRETARY TO: (1)
8 EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE
9 CITY, (A) AN AGREEMENT WITH SHANDS
10 JACKSONVILLE MEDICAL CENTER, INC., AND (B)
11 LETTERS OF AGREEMENT WITH THE STATE OF FLORIDA
12 THROUGH ITS AGENCY FOR HEALTH CARE
13 ADMINISTRATION, BOTH CONCERNING PAYMENT AND
14 DISTRIBUTION OF THE CITY'S INDIGENT HEALTH CARE
15 FUNDS IN THE AMOUNT OF \$40,000,000 FOR FISCAL
16 YEAR 2023-2024, AND (2) TAKE SUCH FURTHER ACTION
17 AS MAY BE NECESSARY OR APPROPRIATE TO EFFECTUATE
18 THE PURPOSE OF THIS ORDINANCE; PROVIDING AN
19 EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Authorization.** The Mayor, or her designee, and
23 Corporation Secretary are hereby authorized to: (1) execute and
24 deliver (a) an agreement between the City of Jacksonville and Shands
25 Jacksonville Medical Center, Inc. ("Shands"), in substantially the
26 same form as is attached hereto as **Revised Exhibit 1**, labeled as
27 "Revised Exhibit 1, Rev Agmt, September 19, 2023 - Finance" and
28 incorporated herein by this reference, and (b) Letters of Agreement
29 between the City of Jacksonville and the State of Florida Agency for
30 Health Care Administration, in substantially the same forms as are
31 attached hereto as **Exhibit 2** and **Revised Exhibit 3**, labeled as

1 "Revised Exhibit 3, Rev DSH LOA, September 19, 2023 - Finance" and
2 incorporated herein by this reference (collectively, the
3 "Agreements"), all of which concern payment and distribution of the
4 City's indigent health care funds in the amount of \$40,000,000 for
5 fiscal year 2023-2024 and, (2) take such further action as may be
6 necessary or appropriate to effectuate the purpose of this Ordinance,
7 including executing any amendments to the Agreements as mutually
8 agreed to by the parties thereto, subject to review thereof by the
9 Office of General Counsel and provided the same do not increase any
10 financial obligation or liability of the City. No agreements between
11 the City and the State of Florida, Agency for Health Care
12 Administration, will be executed and no funding disbursed by the City
13 to the State until the City confirms adequate participation in the
14 IGT program by other counties and government entities in the State.

15 **Section 2. Purpose.** The purpose of this Ordinance is to
16 provide for the distribution of the City's contribution to indigent
17 health care funding between Shands and the State of Florida as part
18 of the State's Medicaid Hospital Program.

19 **Section 3. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
