AN ORDINANCE REGARDING THE FY 2022-2023 CITY GRANT AGREEMENT BETWEEN FOBT PIPLINE, INC., A FLORIDA NOT FOR PROFIT CORPORATION ("FOBT"), AND THE CITY OF JACKSONVILLE ("FY23 CITY GRANT AGREEMENT"); WAIVING FOBT'S NON-COMPLIANCE WITH THE PERMIT REQUIREMENT PROVISION IN THE FY23 CITY GRANT AGREEMENT; AUTHORIZING THE COUNCIL AUDITOR TO REMOVE THE AGENCY FROM THE CHAPTER 118 NON-COMPLIANCE LIST; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

18 WHEREAS, the City of Jacksonville (the "City") pursuant to 19 Ordinance 2022-504-E awarded FOBT Pipeline, Inc., a Florida 20 not-for-profit corporation ("FOBT"), a City grant in the amount of 21 \$165,000 for the Green District Phase I Affordable Housing Project 22 in Durkeeville (the "Affordable Housing Project"); and

WHEREAS, in accordance with Ordinance 2022-504-E, the City and FOBT executed the FY 2022-2023 City Grant Agreement dated October 1, 2022 ("FY23 City Grant Agreement"), in the amount of \$165,000 to fund the Affordable Housing Project; and

27 WHEREAS, pursuant to Section II.B.2 of the City Grant 28 Agreement, FOBT was required to obtain and maintain all permits 29 required by the State of Florida during the FY23 City Grant 30 Agreement term (the "Permit Requirement"); and

WHEREAS, FOBT inadvertently failed to comply with the Permit

Requirement during the FY23 City Grant Agreement term; and

2 WHEREAS, FOBT is otherwise in compliance with the City Grant 3 Agreement terms and Chapter 118, Parts 1-5 of the Ordinance Code, 4 and the City Council agrees to waive FOBT's non-compliance with the 5 Permit Requirement as provided herein; now therefore

6 Section 1. Recital. The recitals above are true and 7 correct and incorporated herein by reference.

8 Section 2. Waiving FOBT's Non-Compliance with the Permit 9 Requirement Provision in the FY23 City Grant Agreement. The 10 Council hereby waives FOBT's non-compliance with the Permit 11 Requirement during the FY23 City Grant Agreement term.

12 Section 3. Removal from the Chapter 118 Non-Compliance 13 List. The City Council authorizes the Council Auditor to remove 14 FOBT Pipeline, Inc. from the Non-Compliance List based on the 15 waiver of FOBT's non-compliance outlined in Section 2.

16 Section 4. Effective Date. This Ordinance shall become 17 effective upon signature by the Mayor or upon becoming effective 18 without the Mayor's signature.
