III. STATEMENTS

A. How does the proposed PUD differ from the usual application of the Zoning Code?

The PUD differs by providing for flexibility and certainty that could otherwise not be accomplished through conventional zoning. It also removes many uses that may be perceived as objectionable to the surrounding neighbors.

B. Describe the intent for the continued operation and maintenance of those areas and functions described herein and facilities which are not to be provided, operated or maintained by the City.

The property owner will maintain all areas and functions of the property.

C. Justification for the rezoning:

The PUD provides for flexibility and certainty that could otherwise not be accomplished through conventional zoning. There may be diminimus landscaping variations to Part 4 that cannot be address with a conventional zoning and are addressed in the Landscaping section of this document.

D. Phase schedule of construction (include initiation dates and completion dates):

This project may be developed in Phases, initiation and completion dates to be determined.

IV. USES AND RESTRICTIONS

A. Permitted Uses:

(1) Commercial retail sales and service establishments

(2) Retail sales of new or used automobiles, trucks and tractors, mobile homes, boats, pawnshops subject to Part 4, automotive vehicle parts (but not automobile wrecking yards, junkyards or scrap processing yards), heavy machinery and equipment, dairy supplies, feed, fertilizer, plant nurseries, lumber and building supplies and similar products.

(3) Service stations, truck stops, automated car wash meeting the performance standards and development criteria set forth in Part 4, auto laundry, mobile car detailing services, major automotive repair, car or truck rental, restaurants, laundromat or dry cleaners, veterinarians, animal boarding kennels meeting the performance standards and development criteria set forth in Part 4, pest control, carpenter or cabinet shops, home equipment rentals, job printing or newspapers, radio or television offices and studios, blood donor stations and similar uses.

(4) Commercial, recreational and entertainment facilities such as carnivals or circuses, theaters (including open-air theaters), skating rinks, athletic complexes, arenas, auditoriums, convention centers, go-cart tracks and driving ranges.

(5) Fruit, vegetable, poultry or fish markets.

(6) All types of professional and business offices.

(7) Small scale operations including wholesaling, warehousing, storage, distributorship business where the total operation does not require more than 10,000 square feet of floor space, no vehicle is used in excess of one and one-half ton capacity, all merchandise is stored within an enclosed building and no heavy machinery or manufacturing is

located on the premises.

- (8) Hospital, nursing homes, assisted living facilities, group care homes, housing for the elderly or orphans and similar uses.
- (9) Light manufacturing, processing (including food processing but not slaughterhouse), packaging or fabricating.
- (10) Day care centers or care centers meeting the performance standards and development criteria set forth in Part 4.
- (11) Recycling collection points meeting the performance standards and development criteria set forth in Part 4.
- (12) Off-street commercial parking lots meeting the performance standards and criteria set forth in Part 4.
- (13) Retail outlets for the sale of used wearing apparel, toys, books, luggage, jewelry, cameras, sporting goods, home furnishings and appliances, furniture and similar uses.
- (14) Essential services, including water, sewer, gas, telephone, radio, television and electric, meeting the performance standards and development criteria set forth in Part 4.
- (15) Adult Congregate Living Facility
- (16) Churches, including a rectory or similar use.
- (17) Personal property storage establishments.
- (18) Vocational, trade or business schools and similar uses.

B. Permissible Uses by Exception:

- (1) Residential treatment facilities and emergency shelters.
- (2) An establishment or facility which includes the retail sale and service of all alcoholic beverages including liquor, beer or wine for on-premises consumption.
- (3) Travel trailer parks meeting the performance standards and development criteria set forth in Part 4.
- (4) Manual car wash.

C. Permitted Accessory Uses and Structures:

1. Accessory Uses and Structures are permitted as provided in section 656.403 of the zoning code.

V. DESIGN GUIDELINES

A. Lot Requirements :

- (1) Minimum lot requirements (width and area): None, except as otherwise required for certain uses
- (2) Maximum lot coverage by all buildings: None, except as otherwise required for certain uses
- (3) Minimum yard requirements:
 - (i) Front- None
 - (ii) Side- None
 - (iii) Rear- Ten
- (4) Maximum height of structures: 60 feet

B. Ingress , Egress and Circulation:

- (1) *Parking Requirements.*
 - a. The parking requirements for this development shall be consistent with Part 6 of the Zoning Code.
- (2) *Vehicular Access.*
 - a. Vehicular access to the Property shall be by way of 103rd Street, as shown in the Site Plan.
- (3) *Pedestrian Access.*
 - a. Pedestrian access shall be provided by sidewalks previously installed on 103rd Street.

C. Signs:

- a. This development will be consistent with Part 13 Sign Regulations of the Zoning Code.

D. Landscaping:

This development will be consistent with Part 12 Landscaping Requirements and therefore asks for a waiver of section 656.401(q).

E. Recreation and Open Space:

This PUD is a commercial use and does not require recreation space.

F. Utilities:

Water will be provided by: JEA

Sanitary sewer will be provided by: JEA

Electric will be provided by: JEA

G. Wetlands:

Wetlands will be permitted according to local, state and federal requirements.

VI. DEVELOPMENT PLAN APPROVAL

With each request for verification of substantial compliance with this PUD, a preliminary development plan shall be submitted to the City of Jacksonville Planning and Development Department identifying all then existing and proposed uses within the Property, and showing the general layout of the overall Property.

VII. PUD REVIEW CRITERIA

- A. Consistency with Comprehensive Plan: According to the Future Land Use Map series (FLUMS) of the 2030 Comprehensive Plan, the proposed designated Land Use is Community/General Commercial (CGC) which allows for the uses requested in the subject PUD.
- B. Consistency with the Concurrency and Mobility Management System: The PUD will satisfy all concurrency requirements as required by the City of Jacksonville Concurrency Management System Office.
- C. Internal Compatibility/Vehicular Access: Vehicular access will be from 103rd Street.
- D. External Compatibility/Intensity of Development: This proposed uses which are compatible with surrounding uses.
- E. Recreation/Open Space: This PUD is a commercial use and does not have a Recreation/Open Space requirement.
- F. Impact on Wetlands: The Property will be developed in accordance with the permit requirements of the local, state and federal agencies with jurisdiction.
- G. Listed Species Regulations: The Subject Property contains less than 50 acres and a listed species survey is not required.
- H. Off Street Parking and Loading Requirements: Parking will be provided as required by Part 6 of the Zoning Code.
- I. Sidewalks shall be provided as required in the Comprehensive Plan.
- J. Stormwater Retention: Stormwater Retention shall meet the requirements of the City of Jacksonville and all other state or local agencies with jurisdiction.
- K. Utilities: The Jacksonville Electric Authority will provide all utilities.
