**ORDINANCE 2025-380**

AN ORDINANCE APPROPRIATING \$15,000.00 IN FUNDING FROM PINNACLE FINANCIAL PARTNERS TO THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT FOR EMERGENCY ROAD ACCESS TEAM NON-CAPITAL SUPPLIES AND EQUIPMENT, AND TRAVEL EXPENSES TO ATTEND THE NATIONAL FALLEN FIREFIGHTERS SERVICE, AS INITIATED BY B.T. 25-079; PROVIDING OVERSIGHT BY THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

The funding above represents an appropriation of funds from Pinnacle Financial Partners for the purchase of supplies and equipment for the Jacksonville Fire and Rescue Department's ("JFRD") Emergency Road Access Team and to provide travel for attendance at the National Fallen

1 Firefighters service in Emmittsburg, Maryland. No local  
2 match is required.

3 **Section 2. Purpose.** The purpose of the appropriation in  
4 Section 1 is to utilize funding from Pinnacle Financial Partners to  
5 purchase non-capital equipment including portable radios, pole saws,  
6 helmet TIC tracers, and equipment storage bins for the Jacksonville  
7 Fire and Rescue Department's ("JFRD") Emergency Road Access Team, and  
8 provide travel for the JFRD Honor Guard and O'Shea family to attend  
9 the National Fallen Firefighters service in Emmittsburg, Maryland.

10 **Section 3. Oversight.** The Jacksonville Fire and Rescue  
11 Department shall oversee administration of the project described  
12 herein.

13 **Section 4. Effective Date.** This Ordinance shall become  
14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
