5 AN ORDINANCE CLOSING AND ABANDONING AND/OR
6 DISCLAIMING AN UNOPENED AND UNIMPROVED PORTION
7 OF VANDEVIERE AVENUE, AS SHOWN ON THE PLAT OF
8 CHASE HEIGHTS AS RECORDED IN PLAT BOOK 10, PAGE
9 41, OF THE CURRENT PUBLIC RECORDS OF DUVAL
10 COUNTY, FLORIDA, LOCATED IN COUNCIL DISTRICT 9,
11 AT THE REQUEST OF EB FREIGHT LLC; PROVIDING FOR
12 APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Closure and Abandonment.** An unopened and
17 unimproved portion of Vandeviere Avenue, as shown on the Plat of
18 Chase Heights as recorded in Plat Book 10, Page 41, of the current
19 public records of Duval County, Florida, located in Council District
20 9, a depiction and description of which is attached hereto as **Exhibit**
21 **1** and incorporated herein by this reference, is hereby closed and
22 abandoned and/or disclaimed at the request of EB Freight LLC (the
23 "Applicant").

24 The Applicant has paid the closure application fees of \$2,091.00
25 and this sum has been deposited into the City's General Fund. This
26 closure request was reviewed and approved by the various city, state,
27 and utility agencies that might have an interest in the right-of-way
28 and there were no objections to the Applicant's request.

29 **Section 2. Purpose.** The Applicant owns the fee parcel
30 where the closure area is located (R.E. No. 007390-0100) and has
31 requested this closure for the purpose of storing equipment for its

1 trucking company, to fence in the area, install a gate and place
2 crushed asphalt on the ground.

3 **Section 3. Hold Harmless Covenant.** The closure and
4 abandonment by the City of its interests in the right-of-way is
5 subject to Applicant's execution and delivery to the City of a Hold
6 Harmless Covenant, in substantially the same form attached hereto as
7 **Exhibit 2** and incorporated herein by this reference. Accordingly, the
8 closure and abandonment of the right-of-way shall not be recorded in
9 the public records until execution and delivery to the City by the
10 Applicant of the required Hold Harmless Covenant.

11 **Section 4. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
