6 **ORDINANCE 2024-545-E**

7 AN ORDINANCE APPROVING AND AUTHORIZING THE
8 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
9 SECRETARY TO EXECUTE AND DELIVER A FIRST
10 AMENDMENT TO FISCAL YEAR 2023-2024 CURE VIOLENCE
11 SERVICES CONTRACT BETWEEN THE CITY OF
12 JACKSONVILLE ("CITY") AND REINTEGRATION
13 SOLUTIONS, INC. OF JACKSONVILLE TO EXTEND THE
14 TERM AND AMEND THE PROGRAM BUDGET DETAIL;
15 PROVIDING FOR CITY OVERSIGHT BY THE GRANTS AND
16 CONTRACT COMPLIANCE DIVISION; PROVIDING AN
17 EFFECTIVE DATE.

19 **WHEREAS**, the City of Jacksonville (the "City") and
20 Reintegration Solutions, Inc. of Jacksonville ("Recipient"),
21 previously entered into that certain Fiscal Year 2023-2024 Cure
22 Violence Services Contract dated October 1, 2023 (the "Contract"),
23 as authorized by Ordinance 2023-504-E, to provide funding from the
24 City to Recipient in the amount of \$312,766.00 (the "Maximum
25 Indebtedness") to be used to implement the Cure Violence Public Health
26 Violence Reduction Model to interrupt violent conflicts and eliminate
27 violence; and

28 **WHEREAS**, Recipient has requested to amend the Contract to
29 adjust the program budget detail in order to reallocate funding
30 between certain line items of the budget without increasing the
31 Maximum Indebtedness and extend the term of the Contract to allow the

1 City to make the final payment for services in accordance with the
2 revised program budget detail; and

3 **WHEREAS**, the term of the Contract expired on January 31, 2024,
4 and Recipient has requested the City to enter into a First Amendment
5 to Fiscal Year 2023-2024 Cure Violence Services Contract in
6 substantially the form attached hereto as **Revised Exhibit 1**, labeled
7 as "Revised Exhibit 1, Rev 1st Amend, August 19, 2024 - NCSPHS" and
8 incorporated herein by this reference (the "Amendment") having an
9 effective date of January 31, 2024 to revive the Contract and maintain
10 contractual continuity; now therefore

11 **BE IT RESOLVED** by the Council of the City of Jacksonville:

12 **Section 1. Approval and Authorization to Execute Amendment**
13 **to Contract.** There is hereby approved, and the Mayor, or her
14 designee, and the Corporation Secretary are hereby authorized to
15 execute and deliver, the Amendment. The Amendment amends certain line
16 items of the Budget/Fee Schedule and Complete Program Budget Detail
17 to reallocate funding to allow for unforeseen expenses and to correct
18 a discrepancy, without increasing the Maximum Indebtedness, and
19 extends the term of the Contract to allow the City to make the final
20 payment to Recipient for services under the Contract, with all other
21 terms and conditions of the Contract remaining unchanged.

22 **Section 2. Oversight Department.** The Grants and Contract
23 Compliance Division of the Finance Department shall continue to have
24 oversight of the Contract described herein.

25 **Section 3. Effective Date.** This Ordinance shall become
26 effective upon signature by the Mayor or upon becoming effective
27 without the Mayor's signature.
