WHEREAS, for approximately 11 years, and as authorized by City Council pursuant to Ordinance 2014-392-E, Tenant has leased the Don Brewer Center, as depicted in **Exhibit 1** attached hereto, from City for use as a children's Head Start Program, pursuant to that certain Lease Agreement dated as of July 15, 2014, as amended (the "Lease Agreement"), at no cost to Tenant effective as of February 1, 2021 pursuant to Ordinance 2020-760-E; and

10 WHEREAS, in addition, for over 4 years, and as approved by City Council pursuant to Ordinances 2020-760-E and 2024-935-E, Tenant has 11 utilized approximately 2,000 square feet of office space in Building 12 1 of the Kids Hope Alliance Building, located at 1095 A. Philip 13 Randolph Boulevard, Building 1, Jacksonville, Florida, 32206 (the 14 "License Area") and depicted in **Exhibit 2** attached hereto, for 15 related uses pursuant to that certain License Agreement dated April 16 17 21, 2021 between Landlord and Tenant, as amended (the "License Agreement"), at no cost to Tenant; and 18

19 WHEREAS, the Lease Agreement and License Agreement are set to 20 expire on June 30, 2025; and

21 WHEREAS, Tenant recently won a five-year renewal of a federal 22 grant for the Head Start program and the parties now wish to enter 23 amendments to extend the terms of both the Lease Agreement and License 24 Agreement by a period of one (1) year to expire on June 30, 2026, in 25 each case with renewal options in favor of Tenant to extend the term 26 until April 30, 2030, at no cost to Tenant; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

28 Section 1. Fourth Amendment to Lease Agreement Approved and 29 Execution Authorized. There is hereby approved, and the Mayor, or 30 her designee, and Corporation Secretary are hereby authorized to 31 execute and deliver, that certain Fourth Amendment to Lease Agreement

between the City and Licensee, in substantially the form attached hereto as **Exhibit 3** for Licensee's continued lease of the Don Brewer Center for a term of one (1) year to expire on June 30, 2026 with renewal options to extend the term until April 30, 2030, at no cost to Tenant.

Section 2. Third Amendment to License Agreement Approved 6 7 and Execution Authorized. There is hereby approved, and the Mayor, or her designee, and Corporation Secretary are hereby authorized to 8 9 execute and deliver, that certain Third Amendment to License Agreement between the City and Licensee, in substantially the form attached 10 11 hereto as Exhibit 4 for Licensee's continued use and occupancy of the License Area for a term of one (1) year to expire on June 30, 2026, 12 with renewal options to extend the term until April 30, 2030, at no 13 14 cost to Tenant.

Requesting One Cycle Emergency Passage Pursuant 15 Section 3. to Council Rule 4.901 Emergency. One cycle emergency passage of 16 this legislation is requested. The nature of the emergency is that 17 the Lease Agreement and License Agreement are set to expire on June 18 19 30, 2025, and one cycle passage of this bill will enable the parties to enter into amendments to extend the terms thereof prior to 20 21 expiration to facilitate Tenant's continued use of the Don Brewer 22 Center and License Area for provision of the Head Start Program and 23 related services.

24Section 4.Oversight.Kids Hope Alliance shall oversee25the Lease Agreement and License Agreement described herein.

26 Section 5. Effective Date. This Ordinance shall become 27 effective upon signature by the Mayor or upon becoming effective 28 without the Mayor's signature.
