5 AN ORDINANCE APPROVING, AND AUTHORIZING THE  
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER A FIRST  
8 AMENDMENT TO FISCAL YEAR 2025-2026 CITY GRANT  
9 AGREEMENT FOR THE UNITED WAY 2-1-1 PROGRAM (CITY  
10 CONTRACT #701375-26), BETWEEN THE CITY OF  
11 JACKSONVILLE AND UNITED WAY OF NORTHEAST  
12 FLORIDA, INC., TO AMEND THE PROGRAM BUDGET  
13 DETAIL AND NARRATIVE; PROVIDING FOR CONTINUED  
14 OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE  
15 DIVISION OF THE FINANCE DEPARTMENT; PROVIDING  
16 AN EFFECTIVE DATE.

18 **WHEREAS**, the City of Jacksonville ("City") and United Way of  
19 Northeast Florida, Inc. ("United Way") previously entered into that  
20 certain Fiscal Year 2025-2026 City Grant Agreement for the United Way  
21 2-1-1 Program (City Contract #701375-26) dated February 2, 2026 (the  
22 "Contract"), as authorized by Ordinance 2025-504-E, to provide  
23 funding from the City to United Way in the amount of \$250,000.00 (the  
24 "Maximum Indebtedness") to be used to implement the 2-1-1 Program  
25 which is a confidential information and referral helpline connected  
26 with a crisis and suicide prevention hotline; and

27 **WHEREAS**, United Way has requested to amend the Contract to  
28 adjust the program budget details to reallocate funding between  
29 certain line items of the budget without increasing the Maximum  
30 Indebtedness and apply the revised program budget details to all  
31 Services provided on and after October 1, 2025; and

1           **WHEREAS**, United Way has requested the City to enter into a  
2 First Amendment to Fiscal Year 2025-2026 City Grant Agreement for the  
3 United Way 2-1-1 Program in substantially the form attached hereto  
4 as **Exhibit 1**, and incorporated herein by this reference (the "First  
5 Amendment"); now therefore

6           **BE IT ORDAINED** by the Council of the City of Jacksonville:

7           **Section 1. Approval and Authorization to Execute First**  
8 **Amendment to Contract.** There is hereby approved, and the Mayor, or  
9 her designee, and the Corporation Secretary are hereby authorized to  
10 execute and deliver the First Amendment. The First Amendment amends  
11 certain line items of the Program Budget Detail and Narrative to  
12 reallocate funding to adjust for internal restructuring of United Way  
13 staff and roles, program needs and resources allocation, with all  
14 other terms and conditions of the Contract remaining unchanged.

15           **Section 2. Oversight.** The Grants and Contract Compliance  
16 Division of the Finance Department shall continue to have oversight  
17 of the Contract described herein.

18           **Section 3. Effective Date.** This Ordinance shall become  
19 effective upon signature by the Mayor or upon becoming effective  
20 without the Mayor's signature.
