PROGRAM OVERVIEW:

Empowering future leaders is crucial for a community's success. Currently, many schools in Council District 9's westside communities are rated 'C' or lower, highlighting the need for improved academic achievement. To address this issue, integrating a robust leadership program with the existing educational framework can significantly enhance students' confidence and academic performance. While education provides the essential foundation for lifelong learning, youth leadership programs foster a passion for continuous improvement and community service. Investing in a proven and effective youth leadership program can better prepare students for post-secondary success and ensure a stronger future for all.

This Program will engage middle school students in Council District 9, empowering them with essential leadership skills to become effective servant leaders.

Funding for the Westside STARS leadership Program would be allocated to increase leadership skills to students enrolled in Lake Shore Middle School.

PROGRAM SCOPE OF WORK AND DELIVERABLES:

The Westside STARS Leadership Program will teach essential leadership qualities such as communication, problem-solving, and decision-making to prepare participants to take on leadership roles in their respective school, communities and Council District.

The Program will be operated by a Student Success Coordinator who will provide leadership training and life skills sessions to at least 25 students enrolled in Lake Shore Middle School. This Program will use the model of the nationally recognized I'm A STAR program which has a proven track record of successfully equipping students to become effective communicators and empowered leaders.

PROGRAM COSTS/PAYMENT TERMS:

City funds will be expensed in accordance with the approved budget and will be paid on a reimbursement basis upon the City's receipt and approval of required documentation including but not limited to paid invoices, cleared checks and bank statements.

Salaries: \$7,000

Other Office Supplies: \$3,000 (Program Supplies)

PROGRAM IMPACT & REPORTING:

The impact of the youth leadership training program will be significant and far-reaching, encompassing, but not limited to:

- Increase in students' self-confidence, improved communication skills, and enhanced problem-solving abilities over the baseline as identified through pre-participation and post-participation testing.
- Increase in leadership skills: (team collaboration and decision-making) over the baseline as identified through pre-post testing.
- Enhance a sense of civic responsibility and community service.

In year one, Westside STARS Leadership Program will directly serve a cohort of at least 25 students. Additional participants will be added in successive years.

Recipient will provide the City with signed authorization from the Parent/Guardian of each participant, authorizing participation in the Westside STARS Leadership Program, and a survey of the participants regarding the effectiveness of the Program.

ADDITIONAL GRANT REQUIREMENTS AND CONDITIONS:

Recipient's expenditure of City funds for the Program(s) and the provision of services shall be subject to Chapter 118, Parts 1 – 5 of the *Jacksonville Ordinance Code*, and the terms and conditions of any contract entered between the City and Recipient. Recipient shall use the City funds for the Program in accordance with the City Council approved Term Sheet and Program budget. The City's Grant Administrator may amend this Term Sheet and the approved Program budget consistent with the Program needs, provided that any substantial change to this Term Sheet or a budget change not within 10% of the attached Program budget line-items will require City Council approval.
