5 A ORDINANCE CONFIRMING THE APPOINTMENT OF
6 COUNCIL MEMBER KEVIN CARRICO AS A DESIGNATED
7 MEMBER OF THE LEAGUE OF CITIES, FILLING THE SEAT
8 DESIGNATED FOR A FIRST TERM COUNCIL MEMBER, FOR
9 A TERM CONCURRENT WITH THE REMAINING YEARS OF
10 HIS SECOND ELECTED TERM OF OFFICE; WAIVING
11 COUNCIL RULE 1.306 (DESIGNATED LEAGUE OF CITIES
12 AND ASSOCIATION OF COUNTIES COUNCIL MEMBER
13 APPOINTMENTS), *COUNCIL RULES*, AS TO THE
14 REQUIREMENT THAT ONE COUNCIL MEMBER SHALL BE A
15 FIRST TERM COUNCIL MEMBER; PROVIDING AN
16 EFFECTIVE DATE.

18 **WHEREAS**, in order to fully participate and benefit from
19 membership in the League of Cities, Ordinance 2017-97-E authorized
20 two Council Members to attend the League of Cities meetings; and

21 **WHEREAS**, Council Rule 1.306 provides that the City Council
22 President shall appoint a first term Council Member to serve on the
23 League of Cities; now therefore

24 **BE IT RESOLVED** by the Council of the City of Jacksonville:

25 **Section 1. Appointment.** The Council hereby confirms the
26 Council President's appointment of Council Member Kevin Carrico as a
27 designated member of the League of Cities, filling the seat designated
28 for a first term Council Member, for a term concurrent with the
29 remaining years of his second elected term of office.

30 **Section 2. Waiver of Council Rule 1.306 (Designated League**
31 **of Cities and Association of Counties Council Member Appointments),**

1 **Council Rules.** Council Rule 1.306 (Designated League of Cities and
2 Association of Counties Council Member Appointments), Part 3 (Members
3 of Council), Chapter 1 (Organization of the Council), is hereby waived
4 as to the requirement that one Council Member appointed to the League
5 of Cities shall be a first term Council Member. A waiver of Council
6 Rule 1.306 is needed because Council Member Carrico, a second term
7 Council Member, is filling a seat designated for a first term Council
8 Member.

9 **Section 3. Effective Date.** This Resolution shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
