4 **ORDINANCE 2019-362**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE
6 MAYOR AND CORPORATION SECRETARY TO EXECUTE AND
7 DELIVER, FOR AND ON BEHALF OF THE CITY OF
8 JACKSONVILLE ("CITY"), THE FUNDING AGREEMENT
9 FOR MILLERS CREEK DREDGING PROJECT BETWEEN THE
10 MILLERS CREEK SPECIAL DISTRICT AND THE CITY;
11 PROVIDING AN EFFECTIVE DATE.

13 **WHEREAS**, as provided in Ordinance 2014-700-E, the purpose of
14 the Millers Creek Special District ("MCSD") is the continuing
15 maintenance of that portion of Millers Creek located within the
16 MCSD's boundaries; and

17 **WHEREAS**, MCSD has taken steps towards implementing a dredging
18 project for Millers Creek (the "Project"); and

19 **WHEREAS**, MCSD and the City of Jacksonville ("City") have
20 developed a Funding Agreement which sets forth the terms under
21 which the City will contribute its budgeted funds to MCSD to assist
22 in paying for the costs of the Project; and

23 **WHEREAS**, City has budgeted funds of up to \$275,000.00 to
24 contribute to the Project; and

25 **WHEREAS**, MCSD and City desire to enter into the Funding
26 Agreement; now therefore

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Approving and authorizing the Mayor and**
29 **Corporation Secretary to execute Funding Agreement for Millers**
30 **Creek Dredging Project.** There is hereby approved, and the Mayor,
31 or his designee, and Corporation Secretary are hereby authorized to

1 execute and deliver, for and on behalf of the City, the Funding
2 Agreement for Millers Creek Dredging Project between the City and
3 MCSD, in substantially the same form attached hereto as **Exhibit 1**
4 and incorporated herein by this reference. A copy of MCSD's
5 Resolution No. 19-03 approving the Funding Agreement is attached
6 hereto as **Exhibit 2** and incorporated herein by this reference.

7 **Section 2. Effective Date.** This ordinance shall become
8 effective upon signature by the Mayor or upon becoming effective
9 without the Mayor's signature.
