Transportation, Federal Highway Administration, and an additional appropriation of \$70,000.00 from General Fund Operating Fund Balance for the City match, for the Safe Streets & Roads for All Project (the "Project"). The Grant period commences June 2023 and ends February 2025.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide grant funding for the Safe Streets and Roads for All Project which will develop an equitable and performance based Vision Zero Action Plan. The goal is to eliminate all roadway fatalities and serious injuries by 2030, including recommended policies and actionable items to be adopted by City leadership within one (1) year of completion of the Vision Zero Action Plan.

A copy of the Grant Award and Grant Agreement is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 3. Approval of Part-Time Hours. There is hereby approved part-time hours more fully described in R.C. 23-162, attached hereto as **Exhibit 3** and incorporated herein by this reference.

Section 4. Oversight Department. The Planning Development Department shall oversee administration of the Grant and shall provide oversight of the Program and part-time hours described herein.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
