The Public Works Department is requesting a second amendment to an interagency agreement between the City and JEA regarding the transfer of water quality credits. This second amendment reads as follows: JEA agrees to transfer additional excess Water Quality Credits ("Supplemental Credits") to the City subject to the appropriate regulatory agency approval. JEA shall diligently pursue the approval of the Supplemental Credits on behalf of the City. Supplemental Credits shall total 74.69 metric tons per year and continued regulatory approval shall be reserved and transferred to the City for the Term of this Agreement, including any term thereof. The Department of Public Works is requesting execution of the agreement by the Mayor.
