12 THE CORPORATION SECRETARY TO EXECUTE AND DELIVER
13 A GRANT AGREEMENT WITH THE STATE OF FLORIDA,
14 DEPARTMENT OF STATE, FOR THE PURPOSE OF
15 PROVIDING THE GRANT FUNDS TO THE CITY; PROVIDING
16 FOR OVERSIGHT BY THE PLANNING DEPARTMENT;

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
21 within the City's budget, there is hereby appropriated the indicated

31 The funding above represents an appropriation of state

grants funds held in the Miscellaneous Grant Projects fund to conduct an oral history and wayfinding tour for the historic Mayport Village community.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide grant funding of \$50,000 to conduct an oral history and wayfinding tour for the historic Mayport Village community. The scope of work includes procuring professional historic preservation services, conducting archival research, conducting a minimum of five oral history interviews, installing eight interpretive signs, and developing a wayfinding tour.

Section 3. Approval of and authorization to enter Grant Agreement. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, the Grant Agreement between the City of Jacksonville and the State of Florida, Department of State, in substantially the same form as attached as **Exhibit 2** and incorporated herein by reference for the purposes of providing funds for the grant to the City and enabling the City to fund an oral history and wayfinding tour for the historic Mayport Village community.

Section 4. Oversight. The City of Jacksonville Planning Department will provide oversight.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
