

THE CHAIRMAN: None. Okay. With that, we have recommended renaming Fingerlake Street to Fairgrounds Way.

We have one more renaming to consider.

MR. WELLS: Okay. So this renaming is for Catherine Street to Henry Bradley Place. This name change is to facilitate coordination with the planned naming of the abutting City-owned firefighters museum as the Henry Bradley Firefighters Museum. As you may recall from our meeting -- it might have been two meetings ago, but Firefighter Bradley was the first City of Jacksonville firefighter to die in the line of duty.

Based on our analysis, we found that Catherine Street can be traced back to its original plat of Jacksonville in June of 1822 where it served as the city's eastern boundary.

The subject street has ties to the Doggett family, which is known as one of the oldest and most prominent families in Jacksonville, and they were around in the 1820s and the 20th century. Their contributions stem from being involved in law, politics, philanthropy. One member in particular who was known as John Locke Doggett, Sr., named Catherine

Street after his daughter Catherine who died at an early age.

The request for the name change will apply to only a portion of Catherine Street as depicted on the location map.

We did find that there is a landmark located along this portion of the subject street, which is, again, the City-owned firefighters museum which was designated as a local landmark by City Council in 2011.

And as you may recall, too, the museum is currently closed for renovations in coordination with the Jacksonville Shipyards West project.

Legislation is currently underway to rename this museum after Henry Bradley. And, again, you all recommended approval of that renaming last month.

Based on our best evidence available, the Department does not have any objection to the proposed street name change, and we forward a recommendation of approval.

THE CHAIRMAN: All right. Any questions for staff?

COMMISSION MEMBERS: (No response.)

THE CHAIRMAN: Okay. Is anybody here to speak on this?

AUDIENCE MEMBERS: (No response.)

THE CHAIRMAN: No? Okay. Let's entertain a motion.

COMMISSIONER EPSTEIN: Motion to approve the street renaming of Catherine Street, as shown on the map, to Henry Bradley Place.

COMMISSIONER LOVE: Second.

THE CHAIRMAN: Any discussion on this?

COMMISSION MEMBERS: (No response.)

THE CHAIRMAN: I'll just say that, before we got to the map part, I was going to not be in favor --

COMMISSIONER EPSTEIN: Yes.

THE CHAIRMAN: -- but the map part was good clarity.

COMMISSIONER EPSTEIN: That's why I said it in my motion.

THE CHAIRMAN: Okay. All in favor?

COMMISSION MEMBERS: Aye.

THE CHAIRMAN: Any opposed?

COMMISSION MEMBERS: (No response.)

THE CHAIRMAN: Okay. We have approved the recommendation of renaming Catherine Street to Henry Bradley Place.
