9 KITTENS IN THE COMMUNITY, AS INITIATED BY B.T.
10 22-023; PURPOSE OF APPROPRIATION; APPROVING, AND
11 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE
12 CORPORATION SECRETARY TO EXECUTE AND DELIVER,
13 FOR AND ON BEHALF OF THE CITY, THE GRANT AWARD
14 AGREEMENT BETWEEN THE CITY AND FLORIDA ANIMAL
15 FRIEND, INC.; PROVIDING FOR OVERSIGHT BY THE
16 NEIGHBORHOODS DEPARTMENT, ANIMAL CARE AND
17 PROTECTIVE SERVICES DIVISION; PROVIDING AN
18 EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
22 within the City's budget, there are hereby appropriated the indicated
23 sum(s) from the account(s) listed in subsection (a) to the account(s)
24 listed in subsection (b):

31 (c) **Explanation of Appropriation**

1 The appropriation above is a grant award from Florida
2 Animal Friend, Inc. The funds will be used to provide spay
3 and neuter services within the community. The grant does
4 not require a match. The grant period ends August 31, 2022.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to fund spay and neuter services to stray and resident-
7 owned free roaming cats and kittens within the community. Any grant
8 funds remaining unspent on August 31, 2022 will be returned to Florida
9 Animal Friend, Inc. in keeping with the grant award.

10 **Section 3. Approval and authorization.** There is hereby
11 approved, and the Mayor, or his designee, and the Corporation
12 Secretary are hereby authorized to execute and deliver for and on
13 behalf of the City, the Grant Award Agreement attached hereto as
14 **Exhibit 2** and incorporated herein by this reference.

15 **Section 4. Oversight.** The Neighborhoods Department,
16 Animal Care and Protective Services Division shall oversee the project
17 described herein.

18 **Section 5. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
