In April 2018, the City of Jacksonville filed a state court lawsuit against opioid manufacturers and distributors, which was subsequently removed to federal court and consolidated by the Mult-District Litigation Panel into the matter styled In re: National Opiate Litigation, MDL No. 2804 (N.D. Ohio). The litigation has been stayed as to all MDL parties until such time that settlements could be effectuated amongst the states and the numerous opioid defendants. The State of Florida is entering a settlement agreement with McKesson, AmerisourceBergen and Cardinal Health (the "Big 3 Distributors"), as well as Johnson & Johnson, which will result in a \$1.6 billion payout to Florida over approximately 18 years. In anticipation of this settlement payment, the State has developed a unified allocation plan for all of its counties and municipalites, which has been memorialized in the Memorandum of Understanding (referred to as the "Florida Plan" and attached to the Ordinance as Exhibit 1). This Ordinance provides the requisite authority for the City to support the Florida Plan and to take such further action as is necessary to participate in the Florida Plan.
