4 **RESOLUTION 2023-468**

5 A RESOLUTION APPOINTING RON SALEM TO THE OPIOID  
6 AND SUBSTANCE USE DISORDER GRANTS COMMITTEE, AS  
7 A LIAISON, PURSUANT TO SECTION 84.202(B),  
8 *ORDINANCE CODE*, FOR A TERM CONCURRENT WITH THE  
9 TERM OF THE COUNCIL PRESIDENT FOR THE 2023-2024  
10 COUNCIL YEAR; PROVIDING AN EFFECTIVE DATE.  
11

12 **WHEREAS**, Ordinance 2019-56-E enacted February 26, 2019,  
13 created a new Chapter 84 (Opioid Abuse Mitigation), *Ordinance Code*,  
14 and established the Opioid Abuse Prevention Committee; and

15 **WHEREAS**, Ordinance 2023-350-E enacted June 27, 2023, repealed  
16 Chapter 84 (Opioid Abuse Mitigation), *Ordinance Code*, in its entirety,  
17 and created a new Chapter 84 (Opioid Settlement Proceeds Grants),  
18 *Ordinance Code*, which established the Opioid and Substance Use  
19 Disorder (OSUD) Grants Committee; and

20 **WHEREAS**, pursuant to Section 84.202(b), *Ordinance Code*, the  
21 City Council President shall annually appoint a City Council Member  
22 to serve as a liaison to the Opioid and Substance Use Disorder Grants  
23 Committee. This is a non-voting position and shall not be considered  
24 a member of the OSUD Grants Committee for Sunshine purposes; now  
25 therefore

26 **BE IT RESOLVED** by the Council of the City of Jacksonville:

27 **Section 1. Appointment.** The Council hereby confirms the  
28 appointment of Council President Ron Salem, to the Opioid and  
29 Substance Use Disorder Grants Committee, as a liaison, pursuant to  
30 Section 84.202(b), *Ordinance Code*, for a term concurrent with the  
31 term of the Council President for the 2023-2024 Council Year.

1           **Section 2.           Effective Date.**   This Resolution shall become  
2 effective upon signature by the Mayor or upon becoming effective  
3 without the Mayor's signature.
