5 AN ORDINANCE APPROPRIATING A \$33,250 GRANT FROM
6 THE HETZEL FAMILY FUND FOR THE BATTERY BEHAVIOR
7 PROGRAM FOR DUVAL COUNTY TEEN COURT, AS
8 INITIATED BY B.T. 22-118; PROVIDING FOR
9 OVERSIGHT AND REPORTING BY THE COURT
10 ADMINISTRATION, DIRECTOR OF TEEN COURTS;
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
15 within the City's budget, there is hereby appropriated the indicated
16 sum(s) from the account(s) listed in subsection (a) to the account(s)
17 listed in subsection (b):

24 (c) Explanation of Appropriation:

25 The funding above represents an appropriation of grant
26 funds received from the Hetzel Family Fund for the Battery
27 Behavior Program for Duval County Teen Court (the "Grant").
28 The two-year Grant period commences on October 1, 2022 and
29 terminates on September 28, 2024. No City match is
30 required.

31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to provide funding for the "Battery Behavior Program for
2 Duval County Teen Court" (the "Program"). The Program will assist
3 youth involved in Teen Court who have received civil citations for
4 misdemeanor battery and domestic battery charges. Grant funds will
5 be used to develop, implement and facilitate a comprehensive,
6 evidence-based treatment program and curriculum for participating
7 youths in accordance with the terms and conditions of the Grant Award
8 Letter attached hereto as **Exhibit 2** and incorporated herein by this
9 reference.

10 **Section 3. Oversight and Reporting.** The Court
11 Administration, Director of Teen Courts, shall oversee administration
12 of the Grant described herein. The Director of Teen Courts shall
13 also be responsible to provide annual reports to the Hetzel Family
14 Fund in accordance with the terms of the Grant.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
