If not stored, if storage not within a completely enclosed building or structure, the property, site, or outside storage use shall be is visually screened by a six-foot fence or wall not less than 95 percent opaque.

Section 3. Severability. The provisions of this Ordinance are intended to be severable and if any provision is declared invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed and the remainder shall continue in full force and effect with the Ordinance being deemed amended to the least degree legally permissible.
