BE IT ORDAINED by the Council of the City of Jacksonville:

Appropriation. For the 2023-2024 fiscal year, 1 Section 1. 2 within the City's budget, there is hereby appropriated the indicated 3 sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b): 4 (The account information is attached hereto as **Exhibit 1** 5 and 6 incorporated herein by this reference) 7 Appropriated from: (a) \$75,000 See Exhibit 1 8 9 (b) Appropriated to: 10 See Exhibit 1 \$75,000 11 (C) Explanation of Appropriation: The funding above is an appropriation of \$75,000 from a 12 Designated Contingency account within the General Fund to 13 the Subsidies and Contributions to Private Organizations 14 15 account within the Kids Hope Alliance ("KHA") Fund to provide funding to Elevate Jacksonville Inc. ("Elevate 16 17 Jax") for the Elevate Jacksonville at Westside High School Program (the "Program") to pay the salary and benefits for 18 a teacher-mentor and the partial expenses for a site 19 coordinator at Westside High School for the 2023-2024

22 Section 2. Purpose. The purpose of the appropriation in 23 Section 1 is to provide funding from the City of Jacksonville to 24 Elevate Jax for the Program as described in **Exhibit 2**, attached hereto 25 and incorporated herein by this reference. The Program will entail 26 placing a teacher-mentor and a site coordinator at Westside High 27 School for the 2023-2024 academic year. The teacher-mentor will spend 28 50% of his/her time teaching accredited elective classes at Westside 29 High School. These classes incorporate character qualities and life 30 skills into the daily classroom curriculum through experiential learning, group activities, and discussions. These qualities and 31

skills are designed to develop the personal character, leadership
abilities, and capabilities needed for success.

Amending Third Revised Schedule M to Ordinance 3 Section 3. 2023-511-E. The Kids Hope Alliance fiscal year 2023-2024 budget 4 approved by Ordinance 2023-511-E is hereby amended by substituting 5 in the place of the Third Revised Schedule M, the Fourth Revised 6 7 Schedule M, attached hereto as **Exhibit 3** and incorporated herein by this reference. The Fourth Revised Schedule M reflects the funds 8 9 appropriated herein as well as adjustments approved by the Council 10 pursuant to Ordinance 2023-847-E.

Section 4. Invoking the Exemption in Section 126.107(g), 11 Ordinance Code. The City is hereby authorized to directly procure 12 the professional services of Elevate Jacksonville Inc. to administer 13 the Program described herein. Pursuant to Section 126.107(g) 14 15 (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code. Such procurement is exempted from competitive 16 17 solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that 18 19 appropriates the same. With the exception of the foregoing, all other 20 provisions of Chapter 126, Ordinance Code, shall remain in full force 21 and effect.

Waiving the Requirements of Section 77.111(a), 22 Section 5. 23 Ordinance Code. The City hereby waives the requirements of Section 24 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance), 25 Ordinance Code, with respect to the contract with Elevate Jacksonville 26 Inc. approved and authorized by this Ordinance. Section 77.111(a) 27 requires contracts for children's services provided by third parties 28 to be competitively procured by KHA via an evaluated bid process. 29 This waiver is needed in order to allow KHA to directly contract with Elevate Jacksonville Inc. for administration of 30 the Elevate 31 Jacksonville at Westside High School Program described in Exhibit 2.

Approval and Authorization to Execute. There is 1 Section 6. 2 hereby approved, and the Mayor, or her designee, and the Corporation Secretary, and/or the Chief Executive Officer of KHA, are hereby 3 authorized to execute and deliver on behalf of the City or KHA, an 4 agreement with Elevate Jacksonville Inc. in an amount not-to-exceed 5 \$75,000. The agreement shall be subject to and administered in 6 7 accordance with Chapter 77, Ordinance Code, and the terms, scope and budget more particularly described in **Exhibit 2**, for a term commencing 8 9 on October 1, 2023 through September 30, 2024, and all other contracts 10 and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate 11 the intent of this Ordinance, subject to appropriate legal review and 12 approval by the General Counsel, or his designee, and the City's Risk 13 Management Division for appropriate insurance and indemnification 14 requirements in accordance with Section 128.601, Ordinance Code. 15

16Section 7.Oversight Department.TheKidsHope17Alliance shall oversee the project described herein.

18 Section 8. Effective Date. This Ordinance shall become 19 effective upon signature by the Mayor or upon becoming effective 20 without the Mayor's signature.
