4 **ORDINANCE 2024-43**

5 AN ORDINANCE APPROPRIATING \$75,000 FROM A
6 DESIGNATED CONTINGENCY ACCOUNT WITHIN THE
7 GENERAL FUND TO THE SUBSIDIES AND CONTRIBUTIONS
8 TO PRIVATE ORGANIZATIONS ACCOUNT WITHIN THE KIDS
9 HOPE ALLIANCE ("KHA") FUND TO PROVIDE FUNDING TO
10 ELEVATE JACKSONVILLE INC. ("ELEVATE JAX") FOR
11 THE ELEVATE JACKSONVILLE AT WESTSIDE HIGH SCHOOL
12 PROGRAM (THE "PROGRAM") DESCRIBED HEREIN;
13 AMENDING THE THIRD REVISED SCHEDULE M TO
14 ORDINANCE 2023-511-E; INVOKING THE EXEMPTION IN
15 SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL
16 REGULATIONS), CHAPTER 126 (PROCUREMENT CODE),
17 *ORDINANCE CODE*, TO ALLOW FOR A DIRECT CONTRACT
18 WITH ELEVATE JAX; WAIVING THE REQUIREMENTS OF
19 SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER
20 77 (KIDS HOPE ALLIANCE), *ORDINANCE CODE*, TO
21 EXEMPT THE SERVICES TO BE PROVIDED BY ELEVATE
22 JACKSONVILLE INC. FROM COMPETITIVE PROCUREMENT;
23 APPROVING, AND AUTHORIZING THE MAYOR, OR HER
24 DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR
25 THE CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE
26 AND DELIVER AN AGREEMENT BETWEEN THE CITY OF
27 JACKSONVILLE OR KHA AND ELEVATE JACKSONVILLE
28 INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY
29 KHA; PROVIDING AN EFFECTIVE DATE.

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 3. Amending Third Revised Schedule M to Ordinance**
4 **2023-511-E.** The Kids Hope Alliance fiscal year 2023-2024 budget
5 approved by Ordinance 2023-511-E is hereby amended by substituting
6 in the place of the Third Revised Schedule M, the Fourth Revised
7 Schedule M, attached hereto as **Exhibit 3** and incorporated herein by
8 this reference. The Fourth Revised Schedule M reflects the funds
9 appropriated herein as well as adjustments approved by the Council
10 pursuant to Ordinance 2023-847-E.

11 **Section 4. Invoking the Exemption in Section 126.107(g),**
12 **Ordinance Code.** The City is hereby authorized to directly procure
13 the professional services of Elevate Jacksonville Inc. to administer
14 the Program described herein. Pursuant to Section 126.107(g)
15 (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement
16 Code), *Ordinance Code*. Such procurement is exempted from competitive
17 solicitation because the supplies or services are to be provided by
18 those specifically prescribed within authorizing legislation that
19 appropriates the same. With the exception of the foregoing, all other
20 provisions of Chapter 126, *Ordinance Code*, shall remain in full force
21 and effect.

22 **Section 5. Waiving the Requirements of Section 77.111(a),**
23 **Ordinance Code.** The City hereby waives the requirements of Section
24 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance),
25 *Ordinance Code*, with respect to the contract with Elevate Jacksonville
26 Inc. approved and authorized by this Ordinance. Section 77.111(a)
27 requires contracts for children's services provided by third parties
28 to be competitively procured by KHA via an evaluated bid process.
29 This waiver is needed in order to allow KHA to directly contract with
30 Elevate Jacksonville Inc. for administration of the Elevate
31 Jacksonville at Westside High School Program described in **Exhibit 2.**

1 **Section 6. Approval and Authorization to Execute.** There is
2 hereby approved, and the Mayor, or her designee, and the Corporation
3 Secretary, and/or the Chief Executive Officer of KHA, are hereby
4 authorized to execute and deliver on behalf of the City or KHA, an
5 agreement with Elevate Jacksonville Inc. in an amount not-to-exceed
6 \$75,000. The agreement shall be subject to and administered in
7 accordance with Chapter 77, *Ordinance Code*, and the terms, scope and
8 budget more particularly described in **Exhibit 2**, for a term commencing
9 on October 1, 2023 through September 30, 2024, and all other contracts
10 and documents, including extensions, renewals and amendments to the
11 agreement, and to otherwise take all action necessary to effectuate
12 the intent of this Ordinance, subject to appropriate legal review and
13 approval by the General Counsel, or his designee, and the City's Risk
14 Management Division for appropriate insurance and indemnification
15 requirements in accordance with Section 128.601, *Ordinance Code*.

16 **Section 7. Oversight Department.** The Kids Hope
17 Alliance shall oversee the project described herein.

18 **Section 8. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
