ORDINANCE 2021-224-E

AN ORDINANCE ADOPTING A MODIFICATION TO THE CITY OF JACKSONVILLE 2030 COMPREHENSIVE PLAN FOR THE PURPOSE OF UPDATING THE FIVE-YEAR CAPITAL IMPROVEMENT SCHEDULE OF PROJECTS WITHIN THE CAPITAL IMPROVEMENTS ELEMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, a modification of the 5-Year Capital Improvements Element Schedule contained in the Capital Improvements Element of the City of Jacksonville 2030 Comprehensive Plan has been initiated by the Planning and Development Department, which modification is more particularly set forth in Exhibit 1, attached hereto; and

WHEREAS, the City Council enacted Ordinance 2020-505-E for the Fiscal Years 2020-2024 Capital Improvement Plan, and the Capital Improvements Element Schedule is a subset of the City's approved Capital Improvement Plan; and

WHEREAS, projects within the Capital Improvements Element Schedule may be funded by local, regional, state or federal governments, or may be privately funded, and therefore, the Capital Improvements Element Schedule includes projects from the North Florida Transportation Planning Organization's Transportation Improvement Plan and Long Range Transportation Plan, as well as the City of Jacksonville's 2030 Mobility Plan; and

WHEREAS, pursuant to Section 163.3177(3)(b), Florida Statutes, the City of Jacksonville may modify the 2030 Comprehensive Plan to update the 5-year Capital Improvements Element Schedule by Ordinance, and such modification is not deemed an amendment to the

2030 Comprehensive Plan; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Modification to 2030 Comprehensive Plan. Capital Improvements Element of the City of Jacksonville 2030 Comprehensive Plan is hereby modified to update the Five-Year Capital Improvement Schedule of Projects within the Capital Improvements Element, as more particularly set forth in Exhibit 1, attached hereto. The Planning and Development Department authorized to include all updates to the Capital Improvement Plan (CIP) approved by the City Council, through the date of enactment of this Ordinance, in the Capital Improvements Element Schedule, and shall place the final Capital Improvements Element Schedule in the file with the City Council Legislative Services Division, and upon ADA compliance, shall publish the final Capital Improvements Element Schedule on the City's website as part of the Capital Improvements Element of the 2030 Comprehensive Plan.

Section 2. Effective Date. This Ordinance shall become effective upon the signature by the Mayor or upon becoming effective without the Mayor's signature.
