AN ORDINANCE APPROPRIATING \$76,181 FROM A GENERAL FUND OPERATING SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE KIDS HOPE ALLIANCE ("KHA") FUND – SPECIAL NEEDS ESSENTIAL SERVICES CATEGORY - SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT, TO PROVIDE FUNDING TO ALLOFUS TOGETHER FOUNDATION INC. ("ALLOFUS TOGETHER") FOR THE AWARENESS FOR AUTISM PROGRAM (THE "PROGRAM") AS DESCRIBED HEREIN; AMENDING THE SECOND REVISED SCHEDULE M TO ORDINANCE 2024-511-E; INVOKING THE EXEMPTION IN SECTION 126.108(G) (EXEMPTIONS FROM COMPETITIVE SOLICITATION), PART 1 (GENERAL REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC CONTRACTING), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH ALLOFUS TOGETHER FOR THE PROGRAM; WAIVING THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY ALLOFUS TOGETHER FROM COMPETITIVE PROCUREMENT; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE OR KHA AND ALLOFUS TOGETHER FOUNDATION INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.
