6 **RESOLUTION 2025-125-A**

7 A RESOLUTION CONFIRMING THE APPOINTMENT OF SALLY
8 PETTEGREW, A DUVAL COUNTY RESIDENT, AS THE
9 CHAIRPERSON OF THE CULTURAL SERVICE GRANT
10 PROGRAM COMMITTEE FOR THE REMAINDER OF HER
11 SECOND FULL TERM EXPIRING DECEMBER 31, 2025,
12 REPLACING ELLEN WILLIAMS, PURSUANT TO SECTION
13 118.605, *ORDINANCE CODE*; REQUESTING ONE CYCLE
14 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, pursuant to Section 118.605(a), *Ordinance Code*, the
17 membership of the Cultural Service Grant Program (CSGP) Committee
18 shall include one non-voting and ten voting members: a CSGP Committee
19 chairperson (non-voting), appointed by the President of the Cultural
20 Council Board of Directors; three other Cultural Council Board members
21 selected by the Board President and Committee Chairperson; and seven
22 individuals selected by the above group (Cultural Council Board
23 President, CSGP Committee chairperson, and three selected Cultural
24 Council Board members) from a pool of nominations established through
25 a community wide nomination process; and

26 **WHEREAS**, pursuant to Section 118.605(c), *Ordinance Code*, CSGP
27 members shall serve a three-year term and may be reappointed for one
28 additional consecutive full term; and

29 **WHEREAS**, pursuant to Resolution 2020-0458-A, Sally Pettegrew
30 was appointed as a member of the CSGP Committee for a first full term
31 expiring December 31, 2022, and pursuant to Resolution 2023-112-A,

1 she was reappointed for a second consecutive full term expiring
2 December 31, 2025; and

3 **WHEREAS,** the Board President of the Cultural Council desires
4 to appoint Sally Pettegrew as Chairperson of the CSGP Committee for
5 the remainder of her second consecutive full term; and

6 **WHEREAS,** pursuant to Section 118.605(d), *Ordinance Code*, all
7 members of the Cultural Service Grant Program Committee shall be
8 confirmed by the City Council; now therefore

9 **BE IT RESOLVED** by the Council of the City of Jacksonville:

10 **Section 1. Confirmation of Appointment.** The City Council
11 hereby confirms the Board President of the Cultural Council of Greater
12 Jacksonville's appointment of Sally Pettegrew, a Duval County
13 resident, as the Chairperson of the Cultural Service Grant Program
14 Committee, for the remainder of her second consecutive full term
15 expiring December 31, 2025, replacing Ellen Williams, pursuant to
16 Section 118.605, *Ordinance Code*.

17 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
18 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
19 legislation is requested to enable the appointee to be seated in time
20 to participate in the Cultural Service Grant Program Committee's
21 Capital Grants review process in February.

22 **Section 3. Effective Date.** This Resolution shall become
23 effective upon signature by the Mayor or upon becoming effective
24 without the Mayor's signature.
