

FLOOR AMENDMENT- BOYLAN
(CULTURAL COUNCIL)

Council Member Boylan offers the following amendment to File 2021-354:

- (1) On **page 1, line 8 and page 4, lines 18, 21 and 23, strike** "B.T. 21-082" and **insert** "Third Revised B.T. 21-082";
- (2) On **page 1, line 28, strike** "AND \$1,278,396.64" and **insert** "478,396.64";
- (3) On **page 1, line 30,** after "EXPENDITURES" **insert** "AND \$800,000.00 IN NONPROFIT BUSINESS RELIEF GRANT FUNDS TO THE CULTURAL COUNCIL OF GREATER JACKSONVILLE, INC. TO COVER ECONOMIC LOSSES FROM BUSINESS INTERRUPTION TO COVID-19";
- (4) On **page 2, line 25,** after "INC.;" **insert** "APPROVING, AND AUTHORIZING THE CITY TO ENTER INTO, A COVID-19 NONPROFIT BUSINESS RELIEF GRANT AGREEMENT WITH THE CULTURAL COUNCIL OF GREATER JACKSONVILLE, INC.;"
- (5) On **page 2, line 28, strike** "AND";
- (6) On **page 2, line 29,** after "INC." **insert** "AND THE CULTURAL COUNCIL OF GREATER JACKSONVILLE, INC.";
- (7) On **page 4, line 18, strike** "Exhibit 1" and **insert** "Third Revised Exhibit 1, labeled as "Third Revised Exhibit 1, Third Revised B.T. 21-087, June 22, 2021 - Floor"";
- (8) On **page 5, line 25-26,** after "COVID-19;" **strike** "and (6) \$1,278,396.64 to be allocated by the City Council for other CARES Act qualifying expenditures." and **insert** "(6) \$478,396.64, to be allocated by the City Council for other CARES Act qualifying expenditures; and (7)

\$800,000.00 to the Cultural Council of Greater Jacksonville to cover economic losses from business interruption and increased need for services due to COVID-19.”;

- (9) On **page 9, line 10½, insert** a new Section 9 to read as follows:

“Section 9. Approval and Authorization to Execute a COVID-19 Nonprofit Business Relief Grant Agreement Between the City and the Cultural Council of Greater Jacksonville, Inc. (“CCGJ”).

There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute a COVID-19 CARES Act Subrecipient Agreement with CCGJ, in substantially the same form as is attached hereto as **Exhibit 7** and incorporated herein by this reference the (“CCGJ Agreement”), in a not-to-exceed amount of \$800,000.00, to be used to offset business interruption expenses and economic losses of CCGJ due to COVID-19, subject to the terms and restrictions of the CARES Act. The CCGJ Agreement may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes set forth in this Ordinance, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, such modifications shall be technical only, subject to appropriate legal review and approval by the Office of General Counsel, and shall be undertaken in compliance with any applicable requirements of the CARES Act,

consistent with the intent of this Ordinance. For the purposes of this Ordinance, the term "technical changes" is defined as those having no financial impact to the City and any other non-substantive changes."

- (10) On **page 8, line 30, strike** "and Cathedral District-Jax, Inc." and **insert** ", Cathedral District-Jax, Inc. and the Cultural Council of Greater Jacksonville, Inc.";
- (11) Renumber remaining sections accordingly;
- (12) Remove **Exhibit 1** and replace with the **Third Revised Exhibit 1**, attached hereto, which attaches Third Revised B.T. 21-082, to add the Cultural Council of Greater Jacksonville, Inc. to recipients of funding;
- (13) Attach **Exhibit 7** attached hereto, which attaches the template agreement for CCGJ;
- (14) The Office of General Counsel is authorized to make all necessary changes to the Exhibits and to Ordinance 2021-354 consistent with the changes set forth herein to effectuate the Council's action;
- (15) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
