4 **ORDINANCE 2026-286-E**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN  
8 STANDARD CONTRACT BETWEEN THE STATE OF FLORIDA  
9 DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP)  
10 AND THE CITY OF JACKSONVILLE FOR PETROLEUM  
11 CONTAMINATION CLEANUP SITE MANAGEMENT  
12 ACTIVITIES; PROVIDING FOR OVERSIGHT BY THE  
13 OFFICE OF ADMINISTRATIVE SERVICES,  
14 ENVIRONMENTAL QUALITY DIVISION; PROVIDING AN  
15 EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Approval and authorization.** There is hereby  
19 approved, and the Mayor, or her designee, and the Corporation  
20 Secretary are hereby authorized to execute and deliver for and on  
21 behalf of the City, that certain Standard Contract (Contract No.  
22 GC192) between the State of Florida Department of Environmental  
23 Protection (FDEP) and the City of Jacksonville ("City") designating  
24 the City to perform petroleum contamination site cleanup management  
25 services on behalf of the FDEP in the Petroleum Restoration Program  
26 (the "Agreement"), in substantially the same form as placed **On File**  
27 with the Legislative Services Division. The Petroleum Restoration  
28 Program helps ensure the clean-up of sites in Duval County, Nassau  
29 County, Baker County, and St. Johns County that are contaminated with  
30 petroleum products in order to protect drinking water supplies and  
31 mitigate health risks associated with petroleum contamination. The

1 Agreement term commences on July 1, 2026, and expires on June 30,  
2 2031, with one five (5) year renewal. The Agreement represents the  
3 continuation of a coordinated effort over the last thirty years  
4 between the parties to address rehabilitation of sites contaminated  
5 by petroleum at the local level without duplication of efforts.

6 **Section 2. Oversight.** The Office of Administrative  
7 Services, Environmental Quality Division shall have oversight of the  
8 project described herein.

9 **Section 3. Effective Date.** This Ordinance shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
