AN ORDINANCE CLOSING AND ABANDONING AND/OR DISCLAIMING AN OPENED AND IMPROVED PORTION OF THE ANDERS BOULEVARD RIGHT-OF-WAY, ESTABLISHED IN THE PLAT OF SOUTHSIDE ESTATES UNIT NO. 24, AS RECORDED IN PLAT BOOK 24, PAGE 25 OF THE CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL DISTRICT 4, AT THE REQUEST OF JOHN H. MOYE AND MICHAEL P. HARRIS, MANAGER OF C & M LAND COMPANY, LLC, SUBJECT TO RESERVATION UNTO JEA OF AN ALL UTILITIES, FACILITIES AND ACCESS EASEMENT; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Closure and Abandonment. An opened and improved portion of the Anders Boulevard right-of-way, established in the Plat of Southside Estates Unit No. 24, as recorded in Plat Book 24, Page 25 of the current public records of Duval County, Florida, located in Council District 4, a depiction and description of which is attached hereto as Exhibit 1 and incorporated herein by this reference, is hereby closed and abandoned and/or disclaimed as a right-of-way at the request of John H. Moye and Michael P. Harris, as Manager and on behalf of C & M Land Company, LLC, (the "Applicant"); provided however, there is reserved unto JEA an all utilities, facilities and access easement on, over, under, through and across the closed right-of-way for ingress and egress and for all utilities and facilities, including but not limited to, water, sewer and

electric, so as to provide JEA continued access to repair and maintain these utilities and facilities. The Applicant paid the right-of-way closure application fee of \$2,091.00 and this amount has been deposited into the General Fund. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

Section 2. Purpose. John H. Moye and C & M Land Company, LLC each owns property adjacent to the closure area at 3820 Southside Boulevard (R.E. No. 125012-0000) and 3742 Southside Boulevard (R.E. No. 124904-0100), respectively, and are requesting the closure for the potential expansion of their businesses on either side of the closure area, subject to the conditions set forth herein.

Hold Harmless Covenant. Section 3. The closure and abandonment by the City of its interests in the right-of-way is subject to Applicant's execution and delivery to the City of a Hold Harmless Covenant, in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, the closure and abandonment of the right-of-way shall not be recorded in the public records until execution and delivery to the City by the Applicant of the required Hold Harmless Covenant.

Effective Date. This Ordinance shall become Section 4. effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
