## ORDINANCE 2023-495-E

ΑN ORDINANCE CONCERNING SURPLUS PERSONAL PROPERTY OF THE CITY; DECLARING THAT CERTAIN 2012 CHEVROLET SILVERADO 2500 HD CREW CAB WORK TRUCK (VIN 1GC1KVCG3CF142817, VEHICLE NUMBER 4954-20) VALUED AT APPROXIMATELY \$11,800 TO BE CITY, TO THE NEEDS OF THEAUTHORIZING THE APPROPRIATE OFFICIALS OF THE CITY TO TRANSFER TITLE OF SAID PROPERTY TO THE VOLUNTEER LIFE SAVING CORPS., INC., LOCATED AT 427 NORTH 3RD STREET, JACKSONVILLE BEACH, FLORIDA 32250, AT NO COST, FOR THE PROVISION OF SUPPLEMENTAL OCEAN RESCUE AND LIFEGUARDING SERVICES ON JACKSONVILLE BEACH, IN ACCORDANCE 122.812(C), *ORDINANCE* WITH SECTION CODE; DESIGNATING THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT TO MONITOR ACTUAL USE OF PROPERTY; PROVIDING FOR A REVERTER; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

Section 1. Declaration of Surplus. The City hereby declares that certain 2012 Chevrolet Silverado 2500 HD Crew Cab Work Truck (VIN 1GC1KVCG3CF142817, vehicle number 4954-20) valued at

approximately \$11,800 (the "Subject Property"), to be surplus to the needs of the City of Jacksonville and authorizes the appropriate City officials to transfer title of the Subject Property to the Volunteer Life Saving Corps., Inc. ("VLSC"), located at 427 North 3<sup>rd</sup> Street, Jacksonville Beach, Florida 32250, at no cost, pursuant to Section 122.812(c), Ordinance Code. A copy of the certificate from the Chief of Procurement certifying compliance with provisions of Chapter 122, Ordinance Code, is attached hereto as Exhibit 1, and incorporated herein by this reference. Copies of the property transfer forms are attached hereto as Exhibit 2.

Section 2. Public Purpose. The Subject Property is needed by the VLSC to provide supplemental ocean rescue and lifeguarding services on Jacksonville Beach. The City of Jacksonville finds that providing the surplussed vehicle to the VLSC to be used for the provision of such services for the Jacksonville community and its visitors is a valid public purpose.

Section 3. Jacksonville Fire and Rescue Department to Monitor Actual Use of Subject Property. The Jacksonville Fire and Rescue Department will be the designated agency to monitor the VLSC's use of the Subject Property in accordance with the purposes set forth herein.

Section 4. Reverter. The disposition authorized herein is conditioned upon the VLSC using the said vehicle for the purposes set forth herein and is conditioned upon the VLSC's agreement to convey and physically return the vehicle back to the City of Jacksonville, at no cost to the City of Jacksonville, in the event that the vehicle is not used for those purposes.

Section 5. Requesting Emergency Passage Upon Introduction

Pursuant to Council Rule 4.901 Emergency. Emergency passage upon introduction of this legislation is requested. The nature of the emergency is that the summer beach season is the busiest time of year

for ocean rescue and lifeguarding services providers. The VLSC has requested transfer of the vehicle as soon as possible so it can be outfitted for this purpose to allow the VLSC to more readily assist in providing these critical emergency services.

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
