5 AN ORDINANCE APPROPRIATING \$101,783.96 OF  
6 REVENUE RECEIVED AS PART OF THE METROPOLITAN  
7 PARKING SOLUTIONS, LLC ("MPS") SETTLEMENT TO  
8 THE DOWNTOWN NORTHBANK CRA TRUST FUND  
9 MISCELLANEOUS SETTLEMENTS OPERATING ACCOUNT TO  
10 BE USED FOR OPERATIONAL EXPENSES FOR THE  
11 COURTHOUSE, ADAMS STREET AND SPORTS COMPLEX  
12 PARKING GARAGES, DE-APPROPRIATING A TOTAL OF  
13 \$1,023,289.55 OF DEBT MANAGEMENT ("DM")  
14 JUDGEMENTS, CLAIMS AND SETTLEMENTS EXPENSE  
15 BUDGET ORIGINALLY APPROPRIATED BY ORDINANCE  
16 2022-137-E, REDUCING REVENUE RECEIVED FOR THE  
17 DOWNTOWN NORTHBANK CRA LONG TERM DEBT ISSUED -  
18 DEBT MANAGEMENT FUND PROCEEDS ACCOUNT BY

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
6 within the City's budget, there is hereby appropriated the  
7 indicated sum(s) from the account(s) listed in subsection (a) to  
8 the account(s) listed in subsection (b):

15 (c) Explanation of Appropriation:

16 The funding above represents an appropriation of  
17 \$101,783.96 in revenue received from the Metropolitan  
18 Parking Solutions, LLC ("MPS") Settlement to the Downtown  
19 Northbank CRA Trust Fund Operating Lease - Leasehold  
20 Improvements account from the MPS Settlement Activity to  
21 the Courthouse, Adams Street and Sports Complex garage  
22 activities, and a de-appropriation of \$5,023,289.55  
23 originally appropriated by Ordinance 2022-137-E,  
24 reflecting a \$5,023,289.55 reduction in revenue received  
25 for the Downtown Northbank CRA Trust Fund Long Term Debt  
26 Issued - Debt Management Fund Proceeds account,  
27 reflecting a \$3,980,694.33 increase in revenue received  
28 for the Downtown Northbank CRA Trust Fund Miscellaneous  
29 Settlements account, and reflecting a \$4,817,599.46  
30 decrease in revenue received by the Debt Management Fund  
31 Long Term Debt Issued account.

1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to reflect actual revenues and expenses received from  
3 the MPS Settlement, and to appropriate funds for operating expenses  
4 for the Courthouse, Adams Street and Sports Complexes Garages.  
5 This legislation will reduce the revenue budget for the Downtown  
6 Northbank CRA Trust Fund Long Term Debt Issued - Debt Management  
7 Fund Proceeds account from \$33,500,000.00 to \$28,476,710.45 (a  
8 reduction of \$5,023,289.55) to reflect actual bond payoff amounts.  
9 In addition, the actions taken by this legislation will increase  
10 the revenue budget for the Downtown Northbank CRA Trust Fund  
11 Miscellaneous Settlements account from \$700,000.00 to \$4,680,694.33  
12 (an increase of \$3,980,694.33) to reflect actual funds received  
13 from the MPS settlement. The \$101,783.93 appropriated to the Trust  
14 Fund Miscellaneous Settlements accounts for the Courthouse, Adams  
15 Street and Sports Complex Parking Garages will be used for  
16 operational expenses.

17           **Section 3.           Amending Revised Schedule B4 to Ordinance**  
18 **2022-504-E.** There is hereby amended for the fiscal year 2022-2023  
19 budget by substituting in the place of the Revised Schedule B4,  
20 approved by Ordinance 2022-504-E, the Second Revised Schedule B4,  
21 attached hereto as **Exhibit 2** and incorporated herein by this  
22 reference. The Second Revised Schedule B4 reflects the additional  
23 transfers and funds appropriated herein.

24           **Section 4.           Effective Date.** This Ordinance shall become  
25 effective upon signature by the Mayor or upon becoming effective  
26 without the Mayor's signature.
