6 FUNDING FROM THE FLORIDA DEPARTMENT OF LAW
7 ENFORCEMENT, THROUGH ITS FY 23-24 STATE
8 FINANCIAL ASSISTANCE FOR FENTANYL ERADICATION
9 (S.A.F.E.) IN FLORIDA PROGRAM, TO THE PSBU
10 GRANTS/FENTANYL AND OPIOID ERADICATION (FOE)
11 PROJECT FY24 TO COMBAT ILLEGAL FENTANYL
12 ACTIVITY, AS INITIATED BY B.T. 24-051; PROVIDING
13 FOR OVERSIGHT BY THE JACKSONVILLE SHERIFF'S
14 OFFICE; PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of grant
29 funds from the Florida Department of Law Enforcement,
30 through its FY 23-24 State Financial Assistance for
31 Fentanyl Eradication (S.A.F.E.) in Florida Program, to the

1 Jacksonville Sheriff's Office PSBU Grants/Fentanyl and
2 Opioid Eradication (FOE) Project FY24 to combat illegal
3 fentanyl activity. The grant period commenced on July 1,
4 2023 and continues through June 30, 2024. No local match
5 is required.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to utilize the Fentanyl and Opioid Eradication (FOE)
8 grant funding from the Florida Department of Law Enforcement through
9 its FY 23-24 State Financial Assistance for Fentanyl Eradication
10 (S.A.F.E.) in Florida Program, to conduct investigations designed to
11 combat illegal fentanyl activity and will cover expenses related to
12 overtime for such investigations. A copy of the Grant Award outlining
13 the terms and conditions relative to the grant and use of the grant
14 funds is attached hereto as **Exhibit 2** and incorporated herein by this
15 reference.

16 **Section 3. Oversight.** The Jacksonville Sheriff's Office
17 shall oversee administration of the grant and project described
18 herein.

19 **Section 4. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
