6 AN ORDINANCE APPROVING A CHANGE IN THE POLLING  
7 PLACE LOCATION FOR PRECINCTS 103, 110, 208,  
8 303, 402, 403, 405, 813, 1010, 1104, AND 1113  
9 AND A NAME CHANGE FOR POLLING LOCATIONS 816,  
10 1202, AND 1313, AND CREATION OF PRECINCT 1116;  
11 APPROVING THE REVISION OF VOTING PRECINCT  
12 BOUNDARIES OF PRECINCTS 1104, 1409, 1410,  
13 1411, 1414 AND 1116, TO BE EFFECTIVE STARTING  
14 FOR THE MARCH 17, 2020 PRESIDENTIAL PREFERENCE  
15 PRIMARY ELECTION, IN THE CITY OF JACKSONVILLE,  
16 DUVAL COUNTY, FLORIDA, AS REQUESTED BY THE  
17 SUPERVISOR OF ELECTIONS PURSUANT TO SECTION  
18 352.102, *ORDINANCE CODE*; PROVIDING AN  
19 EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Precinct Location Change Approved.** At the  
23 request of the Supervisor of Elections for Duval County, and  
24 pursuant to Section 352.102, *Ordinance Code*, the Council, acting as  
25 the governing body for Duval County, hereby approves the polling  
26 place location changes in precincts 103, 110, 208, 303, 402, 403,  
27 405, 813, 1010, 1104, and 1113, a location name change for  
28 precincts 816, 1202, and 1313, and the creation of precinct 1116 as  
29 listed in **Exhibit 1**, attached hereto, to be effective immediately  
30 for all special, primary and general elections conducted after  
31 passage. The Supervisor of Elections and the Council Secretary are

1 hereby authorized and directed to include this precinct and polling  
2 place location in the Polling Place List on file in their  
3 respective offices.

4       **Section 2. Precincts Boundaries Altered.** At the request  
5 of the Supervisor of Elections for Duval County, and pursuant to  
6 Section 352.101, *Ordinance Code*, the Council, acting as the  
7 governing body for Duval County, hereby approves the precinct  
8 boundary changes of precincts 1104, 1409, 1410, 1411, and 1414, and  
9 the creation of precinct 1116. Precinct 1414 is being absorbed into  
10 precinct 1409. The boundaries of the current precincts are shown in  
11 the attached **Exhibit 2**. The boundaries of the altered precincts  
12 which shall be established upon approval of this ordinance are  
13 shown in the attached **Exhibit 3**.

14       **Section 3. Effective Date.** This Ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
