11 *ORDINANCE CODE*, TO PROVIDE SHERIFF'S DISCRETION
12 FOR RETENTION OF BADGES, CAPS, AND SERVICE
13 SIDEARMS; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Amending Section 116.708, Ordinance Code.**

17 Section 116.708 (Disposition of Auxiliary Police Officer's badges,
18 cap and service sidearm upon leaving auxiliary service after 20 or
19 more years), Part 7 (Miscellaneous Employee Benefit Regulations),
20 Chapter 116 (Employees and Employee Benefits), *Ordinance Code*, is
21 hereby amended to read as follows:

22 **CHAPTER 116. EMPLOYEE AND EMPLOYEE BENEFITS.**

24 **PART 7. MISCELLANEOUS EMPLOYEE BENEFIT REGULATIONS.**

26 **Sec. 116.708. Disposition of Auxiliary Police Officer's badges,**
27 **cap and service sidearm upon leaving auxiliary service after 20 or**
28 **more years.**

29 (a) An auxiliary police officer ("Member") who has served as a
30 member of one of the auxiliary units recognized by the Sheriff
31 to assist the Office of the Sheriff in law enforcement

1 activities for a period of 20 or more years and upon
2 certification by the Sheriff that the member is leaving in good
3 standing ~~shall~~ may be entitled, at the Sheriff's discretion,
4 to keep and retain the auxiliary officer's breast badge, pocket
5 badge and service cap with badge and the service sidearm
6 assigned to him or her upon leaving such volunteer service with
7 the auxiliary unit.

8 (b) Upon the death of any Member of the Sheriff's Office Auxiliary
9 Units, the following ~~shall~~ may be entitled, at the Sheriff's
10 discretion, to keep and retain the Member's Sheriff's Office
11 breast badge, pocket badge, service cap with badge and, ~~with~~
12 ~~the consent of the Sheriff,~~ the service sidearm then assigned
13 to the Member.

14 (1) The surviving spouse; or

15 (2) If there is no surviving spouse, the oldest surviving lineal
16 descendant of the Member.

18 **Section 2. Effective.** This ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
