5 **ORDINANCE 2024-941-E**

6 AN ORDINANCE APPROPRIATING \$76,181 FROM A
7 GENERAL FUND OPERATING SPECIAL COUNCIL
8 CONTINGENCY ACCOUNT TO THE KIDS HOPE ALLIANCE
9 ("KHA") FUND - SPECIAL NEEDS ESSENTIAL SERVICES
10 CATEGORY - SUBSIDIES AND CONTRIBUTIONS TO
11 PRIVATE ORGANIZATIONS ACCOUNT, TO PROVIDE
12 FUNDING TO ALLOFUS TOGETHER FOUNDATION INC.
13 ("ALLOFUS TOGETHER") FOR THE AWARENESS FOR
14 AUTISM PROGRAM (THE "PROGRAM") AS DESCRIBED
15 HEREIN; AMENDING THE SECOND REVISED SCHEDULE M
16 TO ORDINANCE 2024-511-E; INVOKING THE EXEMPTION
17 IN SECTION 126.108(G) (EXEMPTIONS FROM
18 COMPETITIVE SOLICITATION), PART 1 (GENERAL
19 REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC
20 CONTRACTING), CHAPTER 126 (PROCUREMENT CODE),
21 *ORDINANCE CODE*, TO ALLOW FOR A DIRECT CONTRACT
22 WITH ALLOFUS TOGETHER FOR THE PROGRAM; WAIVING
23 THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER
24 CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE),
25 *ORDINANCE CODE*, TO EXEMPT THE SERVICES TO BE
26 PROVIDED BY ALLOFUS TOGETHER FROM COMPETITIVE
27 PROCUREMENT; APPROVING, AND AUTHORIZING THE
28 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
29 SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF
30 KHA TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN
31 THE CITY OF JACKSONVILLE OR KHA AND ALLOFUS

1 TOGETHER FOUNDATION INC. FOR THE PROGRAM;
2 PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN
3 EFFECTIVE DATE.

5 **BE IT ORDAINED** by the Council of the City of Jacksonville:

6 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
7 within the City's budget, there is hereby appropriated the indicated
8 sum(s) from the account(s) listed in subsection (a) to the account(s)
9 listed in subsection (b):

16 (c) Explanation of Appropriation:

17 The funding above is an appropriation of \$76,181 from a
18 General Fund Operating Special Council Contingency account
19 to the Kids Hope Alliance ("KHA") Fund - Special Needs
20 Essential Services Category - Subsidies and Contributions
21 to Private Organizations account, to provide funding to
22 Allofus Together Foundation Inc. ("Allofus Together") for
23 the Awareness For Autism Program (the "Program") as
24 described herein.

25 **Section 2. Purpose.** The purpose of the appropriation in
26 Section 1 is to provide funding from the City of Jacksonville to
27 Allofus Together for the Program as described in **Exhibit 2**, attached
28 hereto and incorporated herein by this reference. The Program was
29 created to promote autism spectrum disorder ("ASD" or "autism")
30 awareness and to provide support to children with ASD and their
31 families by providing education, advocacy and community connection.

1 This includes delivering educational workshops and materials to
2 increase autism awareness, providing access to resources regarding
3 local services and coping strategies for families, establishing
4 support groups for families of individuals with ASD, advocating for
5 policy advancement to support individuals with autism, and equipping
6 community leaders and service providers with skills to provide
7 culturally responsive support to individuals with autism. The Program
8 was designed to benefit underserved children and communities in Duval
9 County and the City funds will be used to offset various expenses to
10 operate the Program including expenditures for planning and hosting
11 workshops, group sessions and events, creating and distributing
12 resource materials and tool kits, and media and marketing.

13 **Section 3. Amending Second Revised Schedule M to Ordinance**
14 **2024-511-E.** The Kids Hope Alliance fiscal year 2024-2025 budget
15 approved by Ordinance 2024-511-E is hereby amended by substituting
16 in the place of the Second Revised Schedule M, the Third Revised
17 Schedule M, attached hereto as **Exhibit 3** and incorporated herein by
18 this reference, to reflect the funds appropriated herein.

19 **Section 4. Invoking the Exemption in Section 126.108(g),**
20 **Ordinance Code.** The City is hereby authorized to directly procure
21 the professional services of Allofus Together Foundation Inc. for the
22 Program as described herein. Pursuant to Section 126.108(g)
23 (Exemptions from competitive solicitation), Part 1 (General
24 Regulations; Ethics and Transparency in Public Contracting), Chapter
25 126 (Procurement Code), *Ordinance Code*, such procurement is exempted
26 from competitive solicitation because the supplies or services are
27 to be provided by those specifically prescribed within authorizing
28 legislation. With the exception of the foregoing, all other provisions
29 of Chapter 126, *Ordinance Code*, shall remain in full force and effect.

30 **Section 5. Waiving the Requirements of Section 77.111(a),**
31 **Ordinance Code.** The City hereby waives the requirements of Section

1 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance),
2 *Ordinance Code*, with respect to the contract with Allofus Together
3 approved and authorized by this Ordinance. Section 77.111(a) requires
4 contracts for children's services provided by third parties to be
5 competitively procured by KHA via an evaluated bid process. This
6 waiver is needed in order to allow KHA to directly contract with
7 Allofus Together for the Awareness For Autism Program described in
8 **Exhibit 2.**

9 **Section 6. Approval and Authorization to Execute.** There is
10 hereby approved, and the Mayor, or her designee, and the Corporation
11 Secretary, and/or the Chief Executive Officer of KHA, are hereby
12 authorized to execute and deliver on behalf of the City or KHA, an
13 agreement with Allofus Together Foundation Inc. in an amount
14 not-to-exceed \$76,181. The agreement shall be subject to and
15 administered in accordance with Chapter 77, *Ordinance Code*, and the
16 terms, scope and budget more particularly described in **Exhibit 2**, for
17 a term commencing on October 1, 2024 through September 30, 2025, and
18 all other contracts and documents, including extensions, renewals and
19 amendments to the agreement, and to otherwise take all action
20 necessary to effectuate the intent of this Ordinance, subject to
21 appropriate legal review and approval by the General Counsel, or his
22 designee, and the City's Risk Management Division for appropriate
23 insurance and indemnification requirements in accordance with Section
24 128.601, *Ordinance Code*.

25 **Section 7. Oversight Department.** The Kids Hope Alliance
26 shall oversee the project described herein.

27 **Section 8. Effective Date.** This Ordinance shall become
28 effective upon signature by the Mayor or upon becoming effective
29 without the Mayor's signature.
