RE: Street Name Change from Confederate Street to Rose Arbor Way

Dear Property Owner,

In accordance with Section 745.105, Jacksonville Ordinance Code, the City of Jacksonville received a request for a street name change on Confederate Street in the location of property that you own, identified as Real Estate Number (RE#) 074384 0100. Initially, the previous proposal sought to rename Confederate Street, from Hubbard Street to Market Street North and from Market Street North to Liberty Street North, to "Frazier Place". Now, the proposal will rename Confederate Street to "Rose Arbor Way".

A street name change at the request of a citizen or citizens group requires the agreement of 75% of the owners of property whose property has an assigned address from the street name that is proposed to be changed. According to our data, one or more of the structures on your property is currently addressed from Confederate Street.

Please use the enclosed form to indicate your approval or objection to the proposed street name change. Please return the completed form to the address shown below by **February 16, 2026**.

Please be advised that a failure to return this form on or before the required deadline will be deemed as your consent in favor of the proposed street name change.
