3 account within the Group Health Fund and appropriating
4 \$54,285.00 from fund balance within the Building Inspection
5 Fund to cover the wage increase for International
6 Association of Fire Fighters (IAFF) union employees for
7 fiscal year 2024-2025.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 is to provide funding to cover the various line items
10 outlined in B.T. 25-009 relative to the general wage increase for
11 IAFF union employees effective on October 1, 2024.

12 **Section 3. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
